12 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
13 ORDAIN AS FOLLOWS:

14 SECTION 1: Title 17, Chapter 70, Section 50, of the
15 Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is
16 hereby repealed in its entirety.

17 SECTION 2: Title 17, Chapter 70 of the Municipal
18 Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby
19 amended by adding thereto a new section, designated as Section
20 50, reading as follows:

21 17.70.050: (A) All political signs must be removed within
22 fifteen days after the election to which they pertain. Signs
23 supporting a candidate who loses a primary election or wins a
24 non-partisan race in a primary election with more than fifty per-
25 cent of the vote must be removed within fifteen days after the
26 primary election.

27 (B) The person or persons who are responsible for the
28 erection, placement or distribution of any political sign,
29 including the person whose candidacy the sign supports, are
30 jointly and severally responsible for its removal and the cost
31 thereof.

32 (C) If any sign is not removed within the time period

1 set forth in subsection (A) of this Section, the City may, upon
2 five days' written notice to a candidate or other person respon-
3 sible, remove and dispose of such sign. The City shall certify
4 such removal and charge the candidate or other person responsible
5 for the City's cost for such removal. Removal charges shall be
6 paid within ten days after receipt of a statement of charges.

7 SECTION 3: If any section, subsection, subdivision,
8 paragraph, sentence, clause or phrase in this ordinance or any
9 part thereof, is for any reason held to be unconstitutional or
10 invalid or ineffective by any court of competent jurisdiction,
11 such decision shall not affect the validity or effectiveness of
12 the remaining portions of this ordinance or any part thereof.
13 The City Council of the City of Las Vegas, Nevada, hereby
14 declares that it would have passed each section, subsection, sub-
15 division, paragraph, sentence, clause or phrase thereof irrespec-
16 tive of the fact that any one or more sections, subsections, sub-
17 divisions, paragraphs, sentences, clauses or phrases be declared
18 unconstitutional, invalid or ineffective.

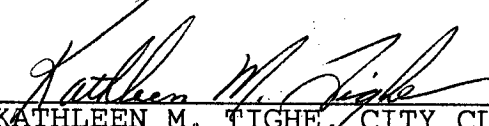
19 SECTION 4: All ordinances or parts of ordinances,

22 1983 Edition, in conflict herewith are hereby repealed.

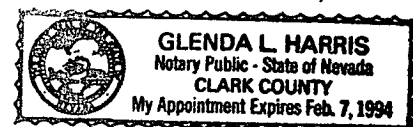

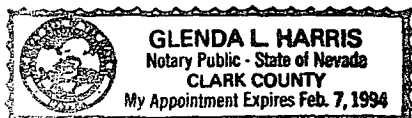
