AN ORDINANCE TO AMEND TITLE V OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY REPEALING CHAPTER 29 THEREOF; BY ADDING THERETO A NEW CHAPTER TO BE DESIGNATED CHAPTER 29, SECTIONS 1 THROUGH 40, PROVIDING FOR THE REGULATION AND CONTROL OF MASSAGE PARLORS; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OR ORDINANCES IN CONFLICT HEREWITH.

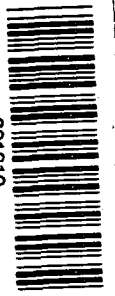
