

ORDINANCE NO. 1537

AN ORDINANCE TO AMEND TITLE IX, CHAPTER 14, SECTION 3 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, 1960 EDITION, TO CLARIFY THAT AMENDMENTS OF THE MAJOR STREET PLAN MAP ARE ADOPTED BY REFERENCE IN THE CITY CODE; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Title IX, Chapter 14, Section 3 of the Municipal Code of the City of Las Vegas, 1960 Edition, is hereby amended to read as follows:

9-14-3 MAP ADOPTED: The official major street plan map, now on file in the office of the Clerk, all explanatory material, and future amendments are hereby adopted by reference and made a part of this Chapter as if fully set forth herein.

SECTION 2. All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith, are hereby repealed.
