THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN
AS FOLLOWS:

Boulder Highway - (Fremont Street) - from Charleston Boulevard to Sahara Avenue

SECTION 9. Title X, Chapter 26, Section 2 of the said Municipal Code is hereby amended by adding to Schedule III thereof the following:

SCHEDULE III

Alley 2E - from Ogden Avenue to Stewart Avenue traffic
shall move only in the northerly direction

SECTION 10. Any person, firm, or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the city jail for not more than six (6) months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.




