ORDINANCE NO. 5078

AN ORDINANCE RELATING TO BUSINESS LICENSING ADMINISTRATIVE PROCEDURES; AMENDING TITLE 6, CHAPTER 2, SECTION 360, AND TITLE 6, CHAPTER 88, SECTION 120, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, TO PROVIDE THAT THE CITY COUNCIL'S AUTHORITY TO IMPOSE A FINE IN CONNECTION WITH AN ADMINISTRATIVE HEARING INCLUDES THE AUTHORITY TO ASSESS A FINE FOR EACH DAY THE RESPONDENT IS FOUND TO HAVE BEEN IN VIOLATION OF APPLICABLE ORDINANCES AND REGULATIONS; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HERewith.

Summary: Authorizes the City Council, as part of a business licensing administrative proceeding, to impose a fine for each day the respondent is found to have been in violation of applicable ordinances and regulations.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
AS FOLLOWS:

SECTION 1: Title 6, Chapter 2, Section 360, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

6.02.360: Upon a showing of good cause and in the discretion of the City Council, disciplinary action against a holder may take the form of cancellation, revocation, refusal to renew, suspension, imposition of conditions or restrictions or civil fine in an amount not to exceed one thousand dollars for each day that the violation which forms the subject matter of the complaint that recommends such disciplinary action [continues after date on which the City Council establishes a date for the consideration of such complaint,] is demonstrated to have been in existence, or any combination of such actions, as the particular situation may require. The Council may also impose against the licensee the actual costs incurred, and a reasonable amount for attorney's fees, resulting from the imposition of disciplinary action. The disciplinary actions available in this Section shall be in addition to, and not exclusive of, any other civil or criminal remedy which otherwise might be available.

SECTION 2: Title 6, Chapter 88, Section 120, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

6.88.120: (A) After the hearing of a contested matter, the City Council shall render a decision on the merits, which shall include findings of fact and conclusions of law and the penalty to be

1 imposed, if any. [, which may, without limitation, include the] The penalty may include, without
2 limitation, the following, or any combination thereof:

3 (1) The suspension or revocation of the respondent's license, approval for
4 suitability or work card, as the case may be ; [, the]

5 (2) The imposition of conditions upon the license, approval for suitability
6 or work card in question; or [the]

7 (3) The imposition of a civil fine in an amount not to exceed one thousand
8 dollars for each day that the violation which forms the subject matter of the complaint [continues after
9 the City Council approves the complaint, or combination of such suspension or revocation, imposition
10 of conditions and imposition of fine, and shall thereafter] is demonstrated to have been in existence.

11 (B) The City Council shall make and enter [its] an order in its minutes in
12 conformity to such decision. The decision of the City Council shall be served on the parties
13 personally or shall be sent to them by registered or certified mail. The decision shall become and
14 remain effective upon such service unless the City Council shall otherwise order.

15 SECTION 3: If any section, subsection, subdivision, paragraph, sentence, clause or
16 phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid
17 or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
18 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
19 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
20 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
21 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
22 invalid or ineffective.

23 SECTION 4: All ordinances or parts of ordinances or sections, subsections, phrases,

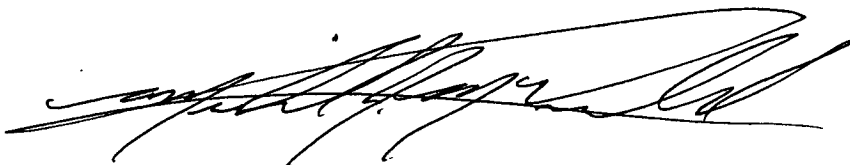

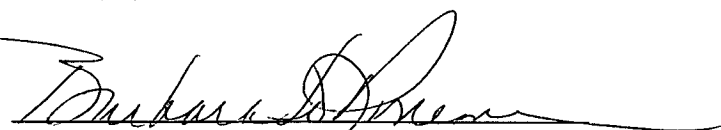

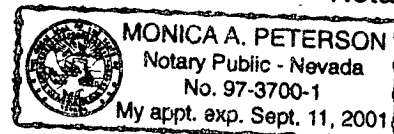
