AN ORDINANCE RELATING TO THE DEPARTMENTS OF THE CITY; AMENDING TITLE 2, CHAPTER 9, SECTION 10, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY ADDING TO THE LIST OF CITY DEPARTMENTS THE DEPARTMENT OF BUILDING AND SAFETY; REPEALING IN ITS ENTIRETY SECTION 20 OF SAID TITLE AND CHAPTER; AMENDING SAID TITLE AND CHAPTER BY ADDING THERETO A NEW SECTION, DESIGNATED AS SECTION 20, TO ESTABLISH THE DIVISIONS OF THE NEW DEPARTMENT OF BUILDING AND SAFETY; AMENDING SAID TITLE AND CHAPTER FURTHER BY ADDING THERETO A NEW SECTION, DESIGNATED AS SECTION 30, TO REFLECT THE DIVISIONS WHICH REMAIN WITHIN THE DEPARTMENT OF PLANNING AND DEVELOPMENT UPON CREATION OF THE DEPARTMENT OF BUILDING AND SAFETY; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HERewith.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
AS FOLLOWS:

SECTION 1: Title 2, Chapter 9, Section 10, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

2.09.010: The departments of the City shall consist of the following:

(A) Building and Safety:

- [(A)] (B) City Attorney;
- [(B)] (C) Detention and Enforcement;
- [(C)] (D) Finance and Business Services;
- [(D)] (E) Fire Services;
- [(E)] (F) General Services;
- [(F)] (G) Human Resources;
- [(G)] (H) Information Technologies;
- [(H)] (I) Municipal Court;
- [(I)] (J) Neighborhood Services;
- [(J)] (K) Parks and Leisure Activities;
- [(K)] (L) Planning and Development;

1 [(L)] (M) Public Works.

2 SECTION 2: Title 2, Chapter 9, Section 20, of the Municipal Code of the City of Las
3 Vegas, Nevada, 1983 Edition, is hereby repealed in its entirety.

4 SECTION 3: Title 2, Chapter 9, of the Municipal Code of the City of Las Vegas,
5 Nevada, 1983 Edition, is hereby amended by adding thereto a new section, designated as Section 20,
6 reading as follows:

7 **2.09.020:** The Department of Building and Safety shall consist of the following
8 divisions:

9 (A) Central permits;

10 (B) Inspections.

11 SECTION 4: Title 2, Chapter 9, of the Municipal Code of the City of Las Vegas,
12 Nevada, 1983 Edition, is hereby amended by adding thereto a new section, designated as Section 30,
13 reading as follows:

14 **2.09.030:** The Department of Planning and Development shall consist of the following
15 divisions:

16 (A) Current planning;

17 (B) Comprehensive planning.

18 SECTION 5: If any section, subsection, subdivision, paragraph, sentence, clause or
19 phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid
20 or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
21 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
22 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
23 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
24 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
25 invalid or ineffective.

26 SECTION 6: All ordinances or parts of ordinances or sections, subsections, phrases,

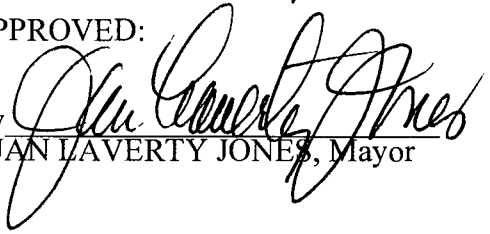
