3 AN ORDINANCE RELATING TO ANIMAL CONTROL; AMENDING TITLE 7, CHAPTER 32,
4 SECTION 250, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983
5 EDITION, TO PROHIBIT THE RELEASE OF ANIMALS FROM THE CITY'S ANIMAL
6 CONTROL CENTER FOR EXPERIMENTAL, LABORATORY OR VIVISECTION PURPOSES;
7 PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING
8 ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Prohibits the release of animals
from the City Animal Control Center for
experimental, laboratory or vivisection
purposes.

11 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
12 AS FOLLOWS:

13 SECTION 1: Title 7, Chapter 32, Section 250, of the Municipal Code of the City of
14 Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

15 **7.32.250:** (A) It shall be a misdemeanor, except as provided in Subsection B, for any person
16 to sell or offer for sale, buy or offer to buy, barter or offer to barter, give or offer to give, or furnish
17 any animal for experimental, laboratory, vivisection, dissection or teaching purposes [except as
18 hereafter provided; nothing herein shall interfere with the sale, buying, barter or gift, by any person,
19 of animals for properly conducted scientific experiments or investigations which are performed under
20 the authority of the faculty or any regularly incorporated medical college or university of this State,
21 or with recognized hospital or laboratory facilities in the course and scope of their work].

22 (B) Any person may sell or offer for sale, buy or offer to buy, barter or offer to
23 barter, give or offer to give, or furnish any animal for properly conducted scientific experiments or
24 investigations which are performed under the authority of the faculty of any regularly incorporated
25 medical college or university of this State, or under the authority of the staff of a licensed hospital or
26 laboratory facility in the course and scope of their work.

27 (C) Notwithstanding the provisions of Subsection (B), the City Animal Control
28 Center shall not knowingly release an animal to any person who intends to use the animal for
experimental, laboratory or vivisection purposes.

SECTION 2: Whenever in this ordinance any act is prohibited or is made or declared

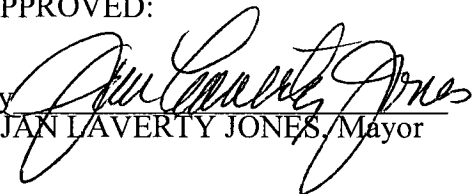
1 to be unlawful or an offense or a misdemeanor, or whenever in this ordinance the doing of any act is
2 required or the failure to do any act is made or declared to be unlawful or an offense or a
3 misdemeanor, the doing of such prohibited act or the failure to do any such required act shall
4 constitute a misdemeanor and upon conviction thereof, shall be punished by a fine of not more than
5 \$1,000.00 or by imprisonment for a term of not more than six months, or by any combination of such
6 fine and imprisonment. Any day of any violation of this ordinance shall constitute a separate offense.

7 SECTION 3: If any section, subsection, subdivision, paragraph, sentence, clause or
8 phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid
9 or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
10 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
11 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
12 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
13 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
14 invalid or ineffective.

15 SECTION 4: All ordinances or parts of ordinances or sections, subsections, phrases,
16 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,
17 1983 Edition, in conflict herewith are hereby repealed.
