ORDINANCE NO. 5074

AN ORDINANCE RELATING TO ZONING; AMENDING TABLE 2 OF THE LAND USE TABLES ADOPTED IN SUBCHAPTER 19A.04.010 OF THE ZONING CODE OF THE CITY OF LAS VEGAS, ADOPTED AS AND INCORPORATED IN TITLE 19A OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, TO REQUIRE A SPECIAL USE PERMIT FOR SERVICE STATION USES IN THE C-1 AND C-2 ZONING DISTRICTS; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Amends the Zoning Code to require a special use permit for service station uses in the C-1 and C-2 Zoning Districts.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
AS FOLLOWS:

SECTION 1: Table 2 of the Land Use Tables adopted in Subchapter 19A.04.010 of the Zoning Code of the City of Las Vegas is hereby amended to require a special use permit for a service station use in the C-1 and C-2 Zoning Districts instead of allowing such use as a conditional use. In order to reflect the amendment, the corresponding boxes found in the "Retail and Personal Services" element of Table 2 shall be changed to indicate the letter "S" (Special Use Permit) in place of the letter "C" (Conditional Use).

SECTION 2: Section 19A.04.040(C) of the Zoning Code of the City of Las Vegas is hereby amended by amending the subsection of Section 19A.04.040(C) entitled "SERVICE STATION" to read as follows, with the bolded brackets ([]) indicating deletion of material and the braces ({ }) representing brackets that are part of existing text:

SERVICE STATION { [C-1, C-2,] C-M, M }

1. All activities and operations shall be conducted entirely within an enclosed structure, except as follows:

- The dispensing of petroleum products, water and air from pump islands.
- The provision of emergency service of a minor nature.
- The sale of items via vending machines which shall be located next to the main structure.

2. Pump islands shall be located a minimum of 20 feet from a street right-of-way line. A canopy

1 or roof structure over a pump island may be located no closer than 10 feet from the street
2 right-of-way line.

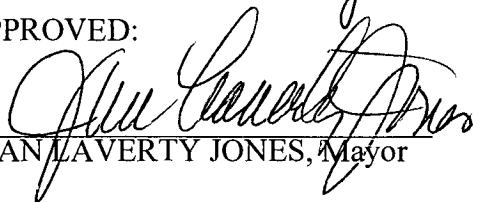
- 3 3. No vehicle shall be parked on the premises for the purposes of offering the vehicle for sale.
4 4. No used or discarded automotive parts or equipment or disabled, junked, or wrecked vehicles
5 shall be located in any open area outside the main structure.
6 5. Noise from bells or loudspeakers shall not be audible beyond the property line at any time.
7 6. The installation of LPG tanks shall only be permitted as allowed in [subchapter] section
8 19A.04.060(B).

9 SECTION 3: If any section, subsection, subdivision, paragraph, sentence, clause or
10 phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid
11 or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
12 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
13 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
14 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
15 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
16 invalid or ineffective.

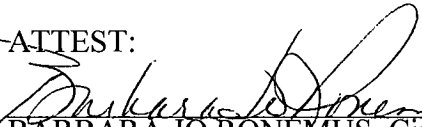
17 SECTION 4: All ordinances or parts of ordinances or sections, subsections, phrases,

19 1983 Edition, in conflict herewith are hereby repealed.

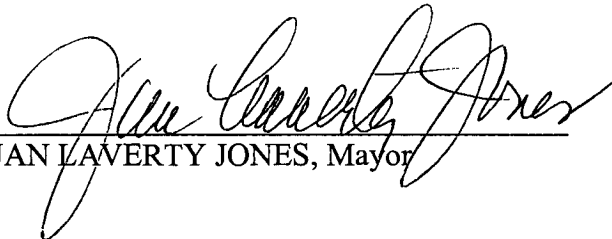

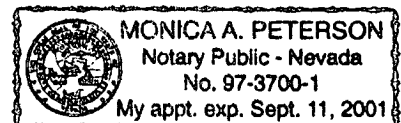

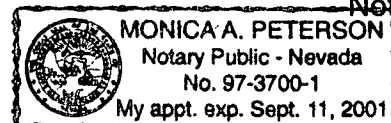
