13 SECTION 1: Section 1 of Ordinance No. 5002 of the City of Las Vegas, and Title 11,
14 Chapter 22, Section 55 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, are
15 hereby amended so that Section 55 reads as follows:

16 **11.22.055:** It is unlawful for any person to use engine compression brakes or any similar braking
17 system while operating a vehicle, other than an emergency vehicle, within the City[.], unless the
18 vehicle is equipped with an operational muffler and exhaust system which complies with Federal and
19 State noise emission standards.

20 SECTION 2: Section 1 of Ordinance No. 5011 of the City of Las Vegas, and Title 11,
21 Chapter 48, Section 50 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, are
22 hereby amended so that Section 50 reads as follows:

23 **11.48.050:** No vehicle in excess of eight thousand pounds unladen weight shall be operated or
24 moved upon any street[, including a truck route,] (other than a truck route) in any residence district
25 between the hours of seven p.m. and six a.m.; provided, however, that the Department of Public
26 Works may, at its discretion, upon application in writing, issue a special permit in writing authorizing
27 the applicant to operate or move such vehicle between the hours of seven p.m. and six a.m. In issuing
28 such permit, the Department may impose such conditions thereon, such as routes to be followed, time

1 of operation or movement, or other matters, as it deems necessary or desirable.

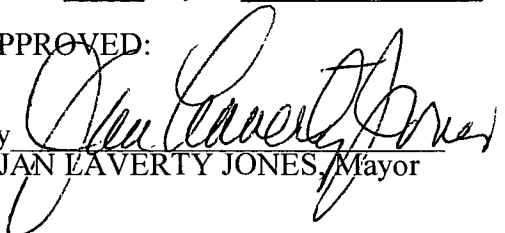
2 SECTION 3: Whenever in this ordinance any act is prohibited or is made or declared
3 to be unlawful or an offense or a misdemeanor, or whenever in this ordinance the doing of any act is
4 required or the failure to do any act is made or declared to be unlawful or an offense or a
5 misdemeanor, the doing of such prohibited act or the failure to do any such required act shall
6 constitute a misdemeanor and upon conviction thereof, shall be punished by a fine of not more than
7 \$1,000.00 or by imprisonment for a term of not more than six months, or by any combination of such
8 fine and imprisonment. Any day of any violation of this ordinance shall constitute a separate offense.

9 SECTION 4: If any section, subsection, subdivision, paragraph, sentence, clause or
10 phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid
11 or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
12 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
13 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
14 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
15 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
16 invalid or ineffective.

17 SECTION 5: All ordinances or parts of ordinances or sections, subsections, phrases,
18 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,
19 1983 Edition, in conflict herewith are hereby repealed.

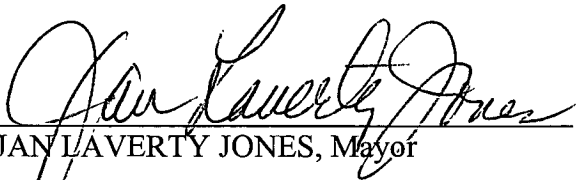

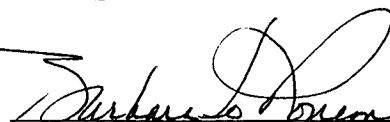
