3 AN ORDINANCE RELATING TO THE CITY'S ETHICS REVIEW BOARD; AMENDING TITLE

5 NEVADA, 1983 EDITION, TO REDUCE THE FREQUENCY OF REQUIRED MEETINGS FROM
6 ONCE A MONTH TO BIMONTHLY, AND TO ELIMINATE OBSOLETE REPORTING
7 PROVISIONS; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO AND
8 REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HERewith.

Summary: Amends the provisions governing the

required meetings from once a month to
bimonthly, and to eliminate obsolete reporting
provisions.

11 THE CITY COUNCIL OF THE CITY OF LAS VEGAS HEREBY ORDAINS AS
12 FOLLOWS:

13 SECTION 1: Title 2, Chapter 51, Section 30, of the Municipal Code of the City of Las
14 Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

15 2.51.030: (A) Creation. An Ethics Review Board is hereby created whose membership shall
16 be constituted and shall have the powers and duties as set forth in this Chapter.

17 (B) Appointment of Members. The Ethics Review Board shall consist of five
18 members, and each member of the City Council, including the Mayor, shall have one appointment.
19 Each member, upon assuming a position as Ethics Review Board member, shall take an oath of office
20 comparable to that taken by Council members. One Ethics Review Board member shall be designated
21 by the Mayor, and confirmed by a majority of the City Council, as Chairperson.

22 (C) Terms. Ethics Review Board members shall serve for four-year, staggered
23 terms. Of the first members appointed, three shall serve for four years (including the Chairperson) and
24 two shall serve for two years. Thereafter, each Ethics Review Board member shall serve for a term
of four years.

25 (D) Compensation. No Ethics Review Board members shall receive a salary, but
26 may be reimbursed for expenses in accordance with City policy.

27 (E) Meetings. The Ethics Review Board shall establish regular meeting times, with
28 no less than one meeting [per month] bimonthly. Special meetings may be called as needed by the

1 Chairperson, or by any two members.

2 (F) Legal Counsel. The City Attorney shall serve as legal counsel to the Ethics
3 Review Board. For each opinion the City Attorney shall prepare at the direction of the Ethics Review
4 Board the appropriate findings of fact and conclusions as to relevant standards and the propriety of
5 particular conduct.

6 (G) Staff. The City Clerk shall designate a member of his/her staff to assist the
7 Ethics Review Board in performing the clerical functions related to meetings of the Ethics Review
8 Board, including the keeping of all necessary records related thereto.

9 (H) Duties. The Ethics Review Board's duties shall include:

10 (1) Rendering binding advisory opinions regarding present and future
11 conduct public board members, officers and employees upon request of the City Attorney pursuant
12 to this Chapter;

13 (2) Rendering advisory opinions regarding past conduct of public board
14 members, officers or employees upon receipt of a [compliant] complaint pursuant to this Chapter;

15 (3) Giving nonbinding recommendations to the City Council and City
16 Attorney on new and existing City policies on ethics;

17 (4) The adoption of procedural regulations to facilitate the receipt of
18 inquiries and prompt rendition of its opinions pursuant to NRS 281.541(b);

19 (5) [The informing of City Clerk of all cases of noncompliance with the
20 requirements of this Chapter;

21 (6)] The recommending to the City Council such further changes to this
22 Chapter as the Ethics Review Board considers desirable or necessary to promote and maintain high
23 standards of ethical conduct in government.

24 (I) Chairperson. The Ethics Review Board member appointed to serve as
25 Chairperson shall preside over all Ethics Review Board meetings, and may call special Ethics Review
26 Board meetings as needed, but otherwise shall have power equal to that of other Ethics Review Board
27 members.

28 SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or

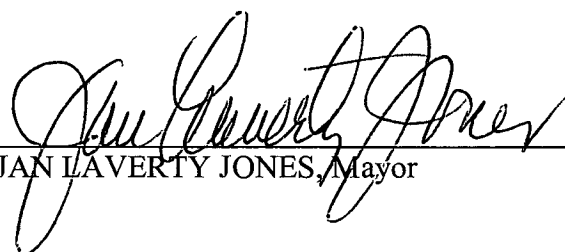

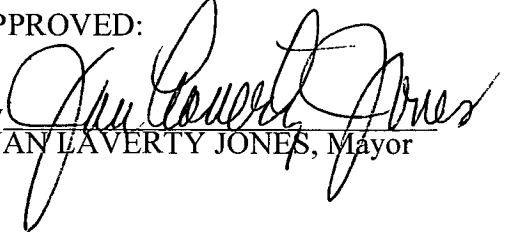

7 invalid or ineffective.

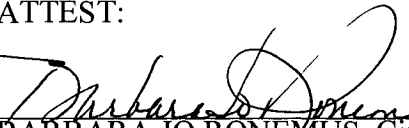
8 SECTION 3: All ordinances or parts of ordinances or sections, subsections, phrases,
