THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
AS FOLLOWS:

SECTION 1: Table 2 of the Land Use Tables adopted in Section 19.04.010 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to allow self-service car washes in the C-1 Zoning District by means of Special Use Permit. In order to reflect the amendment, the letter "S" (indicating Special Use Permit) shall appear in the box that represents the intersection of the column for the C-1 Zoning District with the row for the use "Car Wash, Self-Service," and an asterisk shall appear following the term to indicate the existence of applicable base standards.

SECTION 2: Section 19.04.050 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding to Subsection (B) thereof, at the appropriate location, a new paragraph entitled "CAR WASH (SELF-SERVICE)," reading as follows:

CAR WASH (SELF-SERVICE) [C-1]

1. The hours of operation shall be limited to the period between 7:00 A.M. and 10:00 P.M.
2. Openings to the wash bays shall not face public right-of-way and shall be designed to minimize the visual intrusion into adjoining properties.
3. All exterior lighting shall be screened or otherwise designed so as not to shine directly onto any adjacent parcel.
4. No retail sale of vehicles is allowed.
5. No repair or servicing of vehicles is allowed.



1 6. The use must not be located within 200 feet of a residential property unless the use is separated
2 from the residential property by a street with a minimum right-of-way width of 80 feet.

3 7. The applicant must demonstrate that the use can be made inoperable and inaccessible to the
4 public after business hours.

5 8. Vacuum bays are permitted as part of this use if their operation is in compliance with the other
6 base standards for this use.

7 9. The use must be operated in conjunction with another motor vehicle related use, such as
8 gasoline sales, smog inspection, minor automotive repair, or recreational vehicle and boat storage.

9 10. An attendant must be on the premises during all times the equipment is operational.

10 SECTION 3: In Section 2 of this Ordinance, the brackets that follow the title of the
11 subdivision being added are not intended to indicate deleted matter, but instead are used as the means
12 of indicating the applicable district.

13 SECTION 4: For purposes of Section 2.100(3) of the City Charter, LVMC 19.04.010
14 and 19.04.050 are deemed to be subchapters rather than sections.

15 SECTION 5: If any section, subsection, subdivision, paragraph, sentence, clause or
16 phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid
17 or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
18 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
19 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
20 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
21 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,

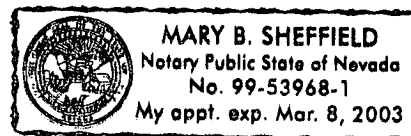

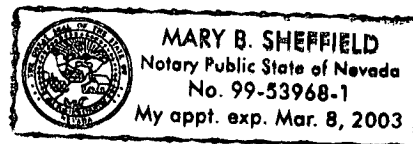
