ORDINANCE NO. 5500

AN ORDINANCE TO EXPAND THE CIRCUMSTANCES IN WHICH OFF-PREMISE SIGNS MAY BE ALLOWED BY MEANS OF SPECIAL USE PERMIT IN THE C-V ZONING DISTRICT, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Summary: Expands the circumstances in which off-premise signs may be allowed by means of special use permit in the C-V Zoning District.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
AS FOLLOWS:

SECTION 1: Section 19.06.020 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by amending Subsection (D) thereof to read as follows:

D. Uses Permitted by Special Use Permit

The following uses may be permitted in the C-V District by means of Special Use Permit if in each case the parcel or use is operated or controlled by an agency of local, state or federal government:

1. Cemetery/Mausoleum
2. Custodial Institution
3. Publicly Operated Convention and Stadium Facility
4. [Off-Premise Sign
- 5.] Liquefied Petroleum Gas Installation
- [6.] 5. General Business Related Gaming Establishment
- [7.] 6. Liquor Establishment (Tavern)

An off-premise sign may be permitted in the C-V District by means of Special Use Permit if in each case the parcel or use is operated or controlled by an agency of local, state or federal government, or by any fraternal, veteran, civic or service organization.

SECTION 2: For purposes of Section 2.100(3) of the City Charter, LVMC 19.06.020 is deemed to be a "subchapter" of the Municipal Code, and Subsection (D) thereof is deemed to be a "section" of the Code.

SECTION 3: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid

1 or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
2 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
3 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
4 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
5 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
6 invalid or ineffective.

7 SECTION 4: All ordinances or parts of ordinances or sections, subsections, phrases,
8 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,
9 1983 Edition, in conflict herewith are hereby repealed.
