AN ORDINANCE RELATING TO FINANCIAL DISCLOSURE OF ELECTED OFFICIALS; AMENDING TITLE 2, CHAPTER 51, SECTION 50 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY CHANGING THE REQUIREMENT TO FILE FINANCIAL DISCLOSURE AT THE TIME OF FILING FOR OFFICE AND GIVING CANDIDATES UNTIL APRIL 15 TO FILE SAME; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: An ordinance amending Title 2, Chapter 51, Section 50 by changing the requirement to file financial disclosure statements at the time of filing for office and giving candidates until April 15 to file same.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 2, Chapter 51, Section 50, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended as follows:

2.51.050: Each candidate for any City elective office shall file with the City Clerk for review by the Council and the public by request, under penalty of perjury, [at the time of his/her filing papers of nomination, or a declaration of candidacy,] no later than the fifteenth day of April, a disclosure statement containing the information set forth in Section 2.51.070 of this Chapter.

SECTION 2: If any section, subsection, subdivision paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof.

1 The City Council of the City of Las Vegas, Nevada, hereby
2 declares that it would have passed each section, subsection, sub-
3 division, paragraph, sentence, clause or phrase thereof,
4 irrespective of the fact that any one or more sections, subsec-
5 tions, subdivisions, paragraphs, sentences, clauses or phrases be
6 declared unconstitutional, invalid or ineffective.

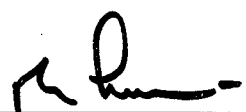
7 SECTION 3: Whenever in this ordinance any act is prohi-
8 bited or is made or declared to be unlawful or an offense or a
9 misdemeanor, or whenever in this ordinance the doing of any act
10 is required or the failure to do any act is made or declared to
11 be unlawful or an offense or a misdemeanor, the doing of any such
12 prohibited act or the failure to do any such required act shall
13 constitute a misdemeanor and upon conviction thereof, shall be
14 punished by a fine of not more than \$1,000.00 or by imprisonment
15 for a term of not more than six months, or by any combination of
16 such fine and imprisonment. Any day of any violation of this
17 ordinance shall constitute a separate offense.

18 SECTION 4: All ordinances or parts of ordinances, sec-
19 tions, subsections, phrases, sentences, clauses or paragraphs
20 contained in the Municipal Code of the City of Las Vegas, Nevada,
21 1983 Edition, in conflict herewith are hereby repealed.

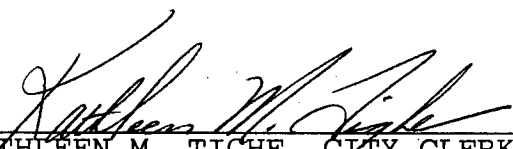

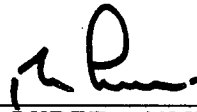

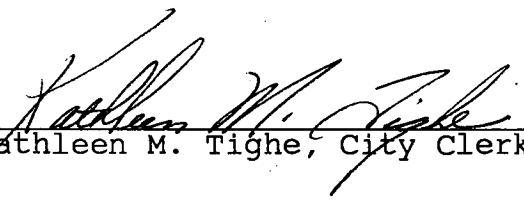
