AN ORDINANCE RELATING TO THE LAS VEGAS ARTS COMMISSION; AMENDING TITLE 2, CHAPTER 34, SECTIONS 50 AND 60 OF THE LAS VEGAS MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, TO EXTEND THE TERM FOR A VOTING MEMBER FROM ONE (1) TO A MAXIMUM OF TWO (2); PROVIDING FOR ALL MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 2, Chapter 34, Section 50, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

2.34.050: The term of each voting member of the Arts Commission shall be for four years and until his or her successor is appointed and qualifies[, except that the initial terms shall be as follows:] and no member shall be reappointed more than once.

- [(A) Two members shall each serve for a term of two years.
- (B) Three members shall each serve for a term of three years.
- (C) Four members, two of whom shall be the members who are appointed by the Arts Commission, shall each serve for a term of four years.]

SECTION 2: Title 2, Chapter 34, Section 60, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

2.34.060: (A) Any member may discontinue his or her membership

1 by resignation and may be removed after a public
2 hearing upon a showing of good cause, by the
3 majority vote of the City Council.

4 (B) If any position becomes vacant, the Mayor, City
5 Councilman or Arts Commission, as the case may be,
6 who appointed the former holder of such position
7 shall appoint a member to serve the balance of the
8 unexpired term.

9 [(C) No member who has served at least two years shall
10 be eligible for reappointment until two years after
11 the last date that that member served on the Arts
12 Commission.]

13 SECTION 3: If any section, subsection, subdivision
14 paragraph, sentence, clause or phrase in this ordinance or any
15 part thereof, is for any reason held to be unconstitutional or
16 invalid or ineffective by any court of competent jurisdiction,
17 such decision shall not affect the validity or effectiveness of
18 the remaining portions of this ordinance or any part thereof.
19 The City Council of the City of Las Vegas, Nevada, hereby
20 declares that it would have passed each section, subsection, sub-
21 division, paragraph, sentence, clause or phrase thereof,
22 irrespective of the fact that any one or more sections, subsec-
23 tions, subdivisions, paragraphs, sentences, clauses or phrases be
24 declared unconstitutional, invalid or ineffective.

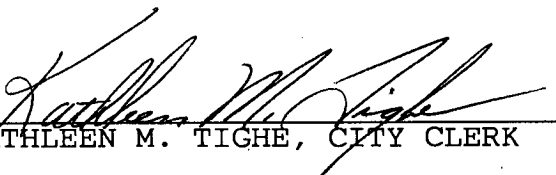

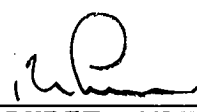

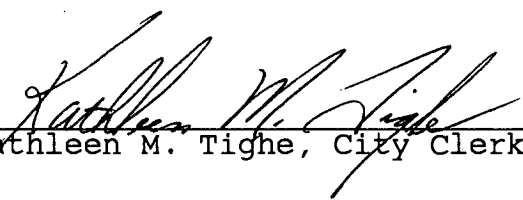
