Ordinance No. 3561

AN ORDINANCE RELATING TO PARKING EXEMPTIONS AMENDING TITLE 11, CHAPTER 54, SECTION 190 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY EXEMPTING ELECTED OFFICERS, THE COUNTY MANAGER AND CITY MANAGERS AND THEIR RESPECTIVE DEPUTY MANAGERS FROM PAYING THE TWENTY-FIVE DOLLAR PARKING EXEMPTION PERMIT FEE; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HERewith.

Summary: Exempts elected officers, the County Manager, City Managers and their respective Deputy Managers, and county and city department heads and their respective deputy department heads from paying the twenty-five dollar parking exemption permit fee.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
ORDAIN AS FOLLOWS:

SECTION 1: Title 11, Chapter 54, Section 190, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

11.54.190: (A) Parking exemption permits shall authorize the persons to whom they are issued to park, without violation, the vehicles to which the permits are affixed in any parking space adjacent to [a street] any parking meter other than a short-term parking meter (12, 15 and 30 minutes) or in any space in a one-hour time-limited parking zone, while actually engaged in field work, subject to the limitations in Subsection (C) of this Section.

(B) The following groups of persons shall be eligible for parking exemption permits upon application to the City Manager or his authorized designee:

(1) Members of news media whether involved in television, radio or newspaper news prepara-

tion or reporting, who are actually in the field preparing or reporting news stories for their employers;

(2) Public [officials] officers and employees of Federal, State, or local governments who are required by their employers to use private automobiles while actually engaged in field work or business outside of their normal offices.

(C) No parking exeption permit shall be approved by the City Manager under this Section unless he receives a letter accompanying the application from the applicant's [supervisor] top administrative officer describing such applicant's job responsibilities and his need for an exempt parking permit and which shows to the City Manager's satisfaction that the employee qualifies for the permit.

(D) [A fee of twenty-five dollars shall be charged for each parking exemption permit issued. The fee shall accompany the parking permit request form. If a parking exemption permit is denied, the money shall be refunded.] A fee of twenty-five dollars shall be charged for each parking exemption permit issued except as indicated in Subsection (G) below.

(E) Once a parking exemption permit is issued to a qualified applicant, it shall be unlawful for such person to use the permit for other than official business, and in no case shall the permit authorize any vehicle to park in any space adjacent to [a street] any parking meter or in any space posted one hour time-limited parking zone for more than two hours continuously.

1 (F) Owners and operators of exempt-plated vehicles
2 shall not be required to apply for, purchase, or
3 display parking exemption permits. Vehicles
4 displaying such license plates shall be authorized
5 to park in any space adjacent to [a street] any
6 parking meter other than a short-term parking meter
7 or in any space posted as a one or two hour time-
8 limited parking zone for not more than two hours
9 continuously.

10 (G) Elected officers, the county manager, city man-
11 agers and their respective deputy managers, and
12 county and city department heads and their respec-
13 tive deputy department heads are exempt from
14 paying the twenty-five dollar parking exemption
15 permit fee.

16 SECTION 2: If any section, subsection, subdivision
17 paragraph, sentence, clause or phrase in this ordinance or any
18 part thereof, is for any reason held to be unconstitutional or
19 invalid or ineffective by any court of competent jurisdiction,
20 such decision shall not affect the validity or effectiveness of
21 the remaining portions of this ordinance or any part thereof.
22 The City Council of the City of Las Vegas, Nevada, hereby
23 declares that it would have passed each section, subsection, sub-
24 division, paragraph, sentence, clause or phrase thereof,
25 irrespective of the fact that any one or more sections, subsec-
26 tions, subdivisions, paragraphs, sentences, clauses or phrases be
27 declared unconstitutional, invalid or ineffective.

28 SECTION 3: All ordinances or parts of ordinances, sec-
