30 division, paragraph, sentence, clause or phrase thereof,
31 irrespective of the fact that any one or more sections, subsec-
32 tions, subdivisions, paragraphs, sentences, clauses or phrases be

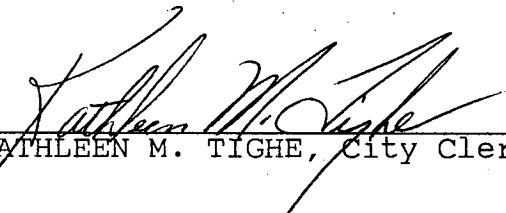
1 declared unconstitutional, invalid or ineffective.

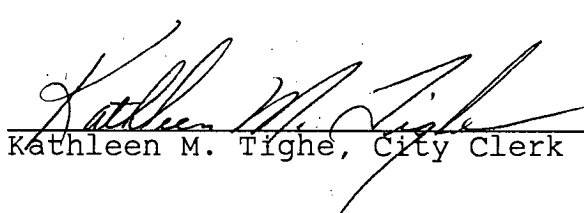

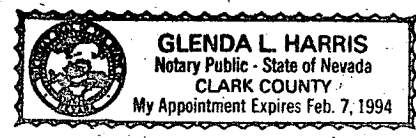
