AN ORDINANCE RELATING TO GAMING CONTROL; REPEALING SECTION 140 OF CHAPTER 40, TITLE 6, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION; ADDING A NEW SECTION TO SAID TITLE AND CHAPTER DESIGNATED AS SECTION 140 LIMITING RESTRICTED GAMING AT ALL LOCATIONS, EXCEPT TAVERNS, LICENSED FOR THE SALE OF ALCOHOLIC BEVERAGES, WITH LESS THAN FIVE THOUSAND SQUARE FEET OF USEABLE FLOOR SPACE, TO THE OPERATION OF NOT MORE THAN SEVEN SLOT MACHINES; PERMITTING LOCATIONS WITHOUT A LICENSE TO SELL ALCOHOLIC BEVERAGES WITH A SPECIAL USE PERMIT FOR A GENERAL BUSINESS RELATED GAMING ESTABLISHMENT WITH AT LEAST FIVE THOUSAND SQUARE FEET OF USEABLE FLOOR SPACE TO OPERATE NOT MORE THAN FIFTEEN SLOT MACHINES; ALLOWING RETENTION OF CURRENT LICENSED SLOT MACHINES; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HERewith.

Sponsored by: Summary: Limits locations with licenses to sell alcoholic beverages other than Councilman Bob Nolen taverns with less than five thousand square feet of useable floor space to the operation of not more than seven slot machines and permits establishments without a liquor license with a special use permit for general business related gaming with at least five thousand square feet of useable floor space to operate up to fifteen slot machines.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 6, Chapter 40, Section 140, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby repealed in its entirety.

SECTION 2: Title 6, Chapter 40, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto a new Section, designated as Section 140, reading as follows:

6.40.140: Restricted gaming shall be limited to the following locations within the City and limited in scope of operation as follows:

(A) Locations licensed for the sale of alcoholic beverages other than a tavern having less than five thousand square feet of useable floor space shall be permitted to operate not more than seven slot machines.

1 (B) Locations licensed for the sale of alcoholic
2 beverages having at least five thousand square feet of useable
3 floor space shall be permitted to operate not more than fifteen
4 slot machines.

5 (C) Locations not licensed for the sale of alcoholic
6 beverages but for which locations a special use permit for a
7 general business related gaming establishment, as that term is
8 defined in LVMC 19.04.417, is obtained in accordance with LVMC
9 Title 19, having less than five thousand square feet of useable
10 floor space shall be permitted to operate not more than four slot
11 machines.

12 (D) Locations not licensed for the sale of alcoholic
13 beverages but for which locations a special use permit for a
14 general business related gaming establishment, as that term is
15 defined in LVMC 19.04.417, is obtained in accordance with LVMC
16 Title 19, having at least five thousand square feet of useable
17 floor space shall be permitted to operate not more than fifteen
18 slot machines.

19 (E) Locations licensed to operate not more than fifteen
20 slot machines prior to February 6, 1991; provided, however, that
21 a location with less than five thousand square feet of useable
22 floor space which has in excess of the number of slot machines
23 permitted by Subsections (A) and (C) of this Section shall be
24 limited to the operation of the number of slot machines licensed
25 for such location as of February 6, 1991.

26 SECTION 3: If any section, subsection, subdivision
27 paragraph, sentence, clause or phrase in this ordinance or any
28 part thereof, is for any reason held to be unconstitutional or
29 invalid or ineffective by any court of competent jurisdiction,
30 such decision shall not affect the validity or effectiveness of
31 the remaining portions of this ordinance or any part thereof.

2 division, paragraph, sentence, clause or phrase thereof,
3 irrespective of the fact that any one or more sections, subsec-

6 SECTION 4: All ordinances or parts of ordinances, sec-
7 tions, subsections, phrases, sentences, clauses or paragraphs
8 contained in the Municipal Code of the City of Las Vegas, Nevada,
9 1983 Edition, in conflict herewith are hereby repealed.

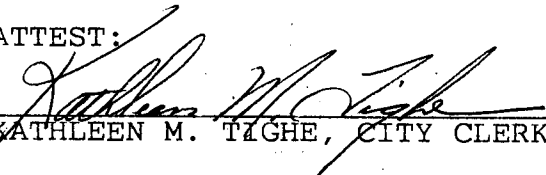

SECTION 1: Title 6, Chapter 40, Section 140, of the
Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is
hereby repealed in its entirety.

SECTION 2: Title 6, Chapter 40, of the Municipal
Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby
amended by adding thereto a new Section, designated as Section
140, reading as follows:

6.40.140: Restricted gaming shall be limited to the following
locations within the City and limited in scope of operation as
follows:

(A) Locations licensed for the sale of alcoholic
beverages other than a tavern having less than five thousand
square feet of useable floor space shall be permitted to operate
not more than seven slot machines.

1 (B) Locations licensed for the sale of alcoholic
2 beverages having at least five thousand square feet of useable
3 floor space shall be permitted to operate not more than fifteen
4 slot machines.

5 (C) Locations not licensed for the sale of alcoholic
6 beverages but for which locations a special use permit for a
7 general business related gaming establishment, as that term is
8 defined in LVMC 19.04.417, is obtained in accordance with LVMC
9 Title 19, having less than five thousand square feet of useable
10 floor space shall be permitted to operate not more than four slot
11 machines.

12 (D) Locations not licensed for the sale of alcoholic
13 beverages but for which locations a special use permit for a
14 general business related gaming establishment, as that term is
15 defined in LVMC 19.04.417, is obtained in accordance with LVMC
16 Title 19, having at least five thousand square feet of useable
17 floor space shall be permitted to operate not more than fifteen
18 slot machines.

19 (E) Locations licensed to operate not more than fifteen
20 slot machines prior to November 7, 1990; provided, however, that
21 a location with less than five thousand square feet of useable
