AN ORDINANCE RELATING TO THE COLLECTION, HAULING AND DISPOSAL OF GARBAGE; AMENDING TITLE 9, CHAPTER 8, SECTIONS 140, 150, 160 AND 170, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, TO ESTABLISH A REVISED SCHEDULE OF CHARGES FOR COLLECTING, HAULING AND DISPOSING OF GARBAGE WITHIN THE CORPORATE BOUNDARIES OF SAID CITY EITHER BY SAID CITY OR BY ITS AUTHORIZED CONTRACTOR; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 9, Chapter 8, Section 140, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

9.08.140: The charge for collecting, hauling and disposing of garbage, rubbish, dirt and small dead animals from single-family residences on a twice-a-week basis shall be as follows: [twenty dollars and seventy cents]twenty-four dollars and forty-five cents per quarter, payable in advance, each and every three-month period.

SECTION 2: Title 9, Chapter 8, Section 150, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

9.08.150: The charge for collecting, hauling and disposing of garbage, rubbish, dirt and small dead animals from apartments and multiple units on a twice-a-week basis shall be a flat rate to be computed as follows: [fifteen dollars and forty-four cents]eighteen dollars and twenty-two cents for the first unit on one stop and [ten dollars and eighty-one cents]twelve dollars and seventy-six cents for each additional unit on one stop, irrespective of occupancy or vacancy of any such additional unit or

1 units, payable each and every three-month period. Should three-
2 days-a-week service be requested by any apartments or multiple
3 units, the rate for such service shall be one and one-half times
4 that for service on a twice-a-week basis and should six-days-a-
5 week service be requested by any apartments or multiple units,
6 the rate for such service shall be two and one-half times that
7 for service on a twice-a-week basis.

8 SECTION 3: Title 9, Chapter 8, Section 160, of the
9 Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is
10 hereby amended to read as follows:

11 9.08.160: The charge for collecting, hauling and disposing of
12 garbage, rubbish, dirt and small dead animals from motels and
13 mobile home parks on a twice-a-week basis, shall be as follows:

15 Sleeping rooms and mobile homes without

16 cooking facilities[\$7.03] \$8.30 per quarter,

17 Rooms where cooking facilities are

18 furnished or mobile homes with cooking

19 facilities[\$9.28] \$10.95 per quarter, and

20 Mobile home parks that require individual collection at each

21 mobile home, the service will be the same as residential ser-

22 vice with a heavy item pick up provided, and the rate shall

23 be [twenty] twenty-four dollars and [seventy] forty-five

24 cents per unit per quarter; provided, however, that the rate

25 for such individual collection without the heavy item pick up

26 shall be [fifteen dollars and forty-four cents] eighteen

27 dollars and twenty-two cents per unit per quarter. Should

28 three-day-a-week service be requested by any motel or mobile

29 home park, the rate for such service shall be one and one-

30 half times that for service on a twice-a-week basis and

31 should six-days-a-week service be requested by any motel or

32 mobile home park, the rate for such service shall be two and

1 one-half times that for service on a twice-a-week basis.

2 SECTION 4: Title 9, Chapter 8, Section 170, of the
3 Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is
4 hereby amended to read as follows:

5 9.08.170: The quarterly charge for collecting, hauling and
6 disposing of garbage, rubbish, dirt and small dead animals from
7 hotels, places of business and public buildings shall be deter-
8 mined by the number and type of receptacles required by each such
9 hotel, place of business or public building and by the number of
10 [daily] collections from each per week in accordance with the
11 following table:

1 SECTION 5: Title 9, Chapter 8, Section 180, of the
2 Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is
3 hereby amended to read as follows:

4 9.08.180: All garbage collection charges or fees prescribed
5 in Sections 9.08.140 through 9.08.170 of this Chapter shall be
6 due and payable quarterly in advance on the first day of each
7 January, April, July and October. In the event any person fails
8 to pay such charge or fee within fifteen days after it becomes
9 due and payable, such charge shall be considered delinquent and
10 an annual penalty of ten percent of such charge or fee shall be
11 added thereto.

12 SECTION 6: If any section, subsection, subdivision,
13 paragraph, sentence, clause or phrase in this ordinance or any
14 part thereof, is for any reason held to be unconstitutional or
15 invalid or ineffective by any court of competent jurisdiction,
16 such decision shall not affect the validity or effectiveness of
17 the remaining portions of this ordinance or any part thereof.
18 The City Council of the City of Las Vegas, Nevada, hereby
19 declares that it would have passed each section, subsection, sub-
20 division, paragraph, sentence, clause or phrase thereof irrespec-
21 tive of the fact that any one or more sections, subsections, sub-
22 divisions, paragraphs, sentences, clauses or phrases be declared
23 unconstitutional, invalid or ineffective.

24 SECTION 7: All ordinances or parts of ordinances,
25 sections, subsections, phrases, sentences, clauses or paragraphs
26 contained in the Municipal Code of the City of Las Vegas, Nevada,

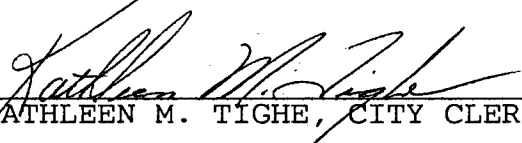

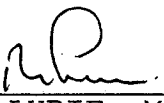

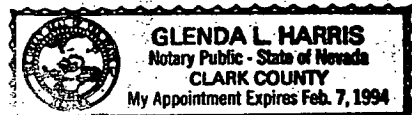
