AN ORDINANCE RELATING TO THE GOLF BOARD AND THE PARKS AND RECREATION ADVISORY COMMISSION; REPEALING TITLE 2, CHAPTER 38, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, AND AMENDING SECTION 80 OF CHAPTER 42 OF SAID TITLE BY EXTENDING THE DUTIES OF THE PARKS AND RECREATION ADVISORY COMMISSION IN RESPECT TO THE MUNICIPAL GOLF COURSE; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO AND REPEALING ALL ORDINANCES IN CONFLICT HEREWITH.

Summary: Repeals Chapter 38 of Title 2 of the Las Vegas Municipal Code, terminating the Golf Board and transferring certain duties of the Board to the Parks and Recreation Advisory Commission.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
ORDAIN AS FOLLOWS:

SECTION 1: Title 2, Chapter 38 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby repealed in its entirety.

SECTION 2: Title 2, Chapter 42, Section 80, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

2.42.080: The duties of the Parks and Recreation Commission shall be:

(A) To make recommendations, in cooperation with the Director of the Department of Parks and Leisure Activities, to the City Council on matters pertaining to public parks and public recreation and to cooperate with other governmental agencies and civic groups to facilitate sound park and recreation planning;

(B) To aid in coordinating the parks and recreation services with other governmental agencies and other voluntary organizations;

(C) To assist in the functions of the Department of Parks and Leisure Activities which involve or affect the public[.] ; and

(D) To make recommendations to the City Council on matters pertaining to the Municipal Golf Course, including but not limited to capital improvements and green fees or any other charges to the public for use of the facilities.

SECTION 3: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas, Nevada, hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

SECTION 4: All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, in conflict herewith are hereby repealed.
