AN ORDINANCE RELATING TO BLASTING PERMITS; AMENDING THE SUPPLEMENTAL DOCUMENT ENTITLED "A SUPPLEMENTAL DOCUMENT AMENDING THE UNIFORM FIRE CODE, 1988 EDITION," ADOPTED AS PART II OF CHAPTER 16.16 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY ADDING TO ARTICLE 77 OF THE UNIFORM FIRE CODE FOUR NEW SECTIONS, DESIGNATED AS SECTIONS 502, 503, 504, AND 505, RESPECTIVELY, TO ESTABLISH MINIMUM REQUIREMENTS FOR BLASTING PERMITS, INCLUDING TIME LIMITATIONS AND REQUIREMENTS FOR NOTIFICATION, INSURANCE, MONITORING, AND INSPECTIONS; PROVIDING FOR PENALTIES FOR THE VIOLATION HEREOF; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: For purposes of Section 2 of this Ordinance, the term "Supplemental Document" means that certain document entitled "A Supplemental Document Amending the Uniform Fire Code, 1988 Edition," adopted by reference as Part II of Chapter 16.16 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition.

SECTION 2: Article 77 of the Uniform Fire Code, as modified in the Supplemental Document, is hereby amended by adding to Division V thereof four new sections, designated as Sections 502, 503, 504, and 505, respectively, reading as follows:

Section 77.502 Standard Requirements

All blasting permits shall be subject to the following minimum requirements:

1. Blasting shall be limited to the maximum number of weeks determined by the Blasting Committee. Any extension of time shall require approval of the Blasting Committee.

2. Blasting shall not be permitted except on Mon-

1 day through Friday from 8 a.m. to 4 p.m. The Blasting Committee
2 may authorize other days and times on a limited basis where spe-
3 cial circumstances exist.

4 3. The maximum single component peak particle
5 velocity shall not exceed 0.5 ips at the nearest occupied struc-
6 ture.

7 4. The contractor shall ensure that monitoring
8 will be provided in accordance with Section 77.504.

9 5. The contractor shall provide prior written
10 notice of the proposed blasting to all residences, businesses and
11 public uses within 1000 feet of the blasting area. The notice
12 shall consist of or include a copy of the Blasting Information
13 Bulletin approved by the Blasting Committee.

14 6. The contractor shall provide prior written
15 notice to any utility company that has facilities located within
16 300 feet of the blasting area.

17 7. The contractor shall remove any debris from
18 adjacent properties that results from blasting.

19 Section 77.503 Insurance Requirements

20 The contractor shall procure liability insurance in the
21 minimum amount of \$1 million naming the City as an additional
22 insured and shall produce evidence thereof to the City before
23 blasting occurs. The insurance company must provide the City
24 with at least a 30 day prior written notice before any can-
25 cellation of policy or reduction in the coverage provided becomes
26 effective.

27 Section 77.504 Monitoring of Blasts

28 The City will provide for the monitoring of blasting
29 that occurs within 1000 feet of any residence or structure or
30 within 300 feet of utility installations.

31 Blast-induced vibration monitoring measurements will be
32 recorded with a Berger SSU 1000 D seismometer or similar instru-

1 ment. This instrument shall sense particle velocity in the three
2 mutually perpendicular axes. Sound levels shall also be
3 recorded.

4 The contractor shall reimburse the City for the costs it
5 incurs in providing for the monitoring activities.

6 Section 77.505 Pre-Blast Inspections

7 The contractor is responsible for providing pre-blast
8 inspections of properties when blasting activities are proposed
9 within close proximity to structures and when required at the
10 discretion of the Blasting Committee. The cost for these inspec-
11 tions shall be at the expense of the contractor.

12 SECTION 3: Whenever in this ordinance any act is
13 prohibited or is made or declared to be unlawful or an offense or
14 a misdemeanor, or whenever in this ordinance the doing of any act
15 is required or the failure to do any act is made or declared to
16 be unlawful or an offense or a misdemeanor, the doing of any such
17 prohibited act or the failure to do any such required act shall
18 constitute a misdemeanor and upon conviction thereof, shall be
19 punished by a fine of not more than \$1,000.00 or by imprisonment
20 for a term of not more than six (6) months, or by any combination
21 of such fine and imprisonment. Any day of any violation of this
22 ordinance shall constitute a separate offense.

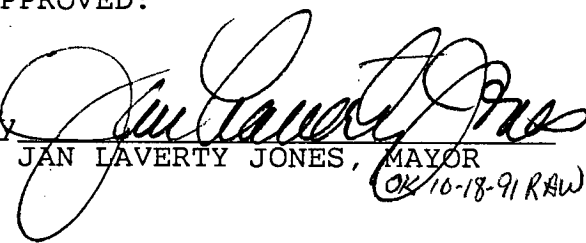
23 SECTION 4: If any section, subsection, subdivision,
24 paragraph, sentence, clause or phrase in this ordinance or any
25 part thereof, is for any reason held to be unconstitutional or
26 invalid or ineffective by any court of competent jurisdiction,
27 such decision shall not affect the validity or effectiveness of
28 the remaining portions of this ordinance or any part thereof.
29 The City Council of the City of Las Vegas, Nevada, hereby
30 declares that it would have passed each section, subsection, sub-
31 division, paragraph, sentence, clause or phrase thereof irrespec-
32 tive of the fact that any one or more sections, subsections, sub-

1 divisions, paragraphs, sentences, clauses or phrases be declared
2 unconstitutional, invalid or ineffective.

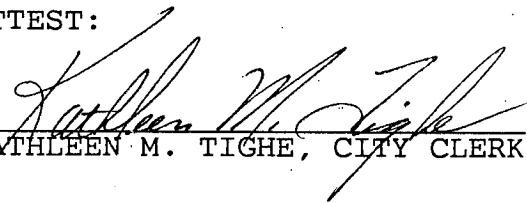
3 SECTION 5: All ordinances or parts of ordinances,

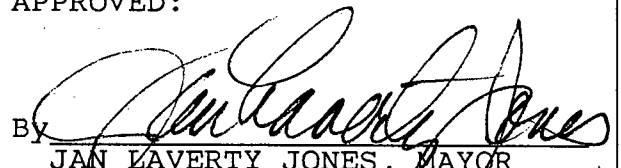

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

2. Blasting shall not be permitted except on Monday through Friday from 8 a.m. to 4 p.m. The Blasting Committee

1 may authorize other days and times on a limited basis where spe-
2 cial circumstances exist.

3 3. The maximum single component peak particle
4 velocity shall not exceed 0.5 ips at the nearest occupied struc-
5 ture.

6 4. The contractor shall ensure that monitoring
7 will be provided in accordance with Section 77.504.

8 5. The contractor shall provide prior written
9 notice of the proposed blasting to all residences within 1000
10 feet of the blasting area. The notice shall consist of or
11 include a copy of the Blasting Information Bulletin approved by
12 the Blasting Committee.

13 6. The contractor shall provide prior written
14 notice to any utility company that has facilities located within
15 300 feet of the blasting area.

16 7. The contractor shall provide written notice to
17 neighboring businesses, public uses, etc. prior to commencing
18 blasting.

19 8. The contractor shall remove any debris from
20 adjacent properties that results from blasting.

21 Section 77.503 Insurance Requirements

22 The contractor shall procure liability insurance in the
23 minimum amount of \$1 million naming the City as an additional
24 insured and shall produce evidence thereof to the City before
25 blasting occurs. The insurance company must provide the City
