ORDINANCE No. 3607

AN ORDINANCE RELATING TO THE OPERATION OF GOLF CARTS; AMENDING TITLE 11 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY ADDING THERETO A NEW CHAPTER, PROVIDING FOR THE DESIGNATION BY SCHEDULE OF THE PUBLIC STREETS WHERE THE OPERATION OF GOLF CARTS IS PERMITTED AND ALLOWING THE OPERATION OF GOLF CARTS ON THESE DESIGNATED STREETS ONLY; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HERewith.

Summary: Provides for the designation by schedule of public streets where the operation of golf carts is permitted and allows for the operation of golf carts on the designated streets.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 11, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto a new chapter to consist of the provisions that are set forth as Sections 2 and 3 of this Ordinance.

SECTION 2: Those streets, parts of streets, or areas described in Schedule 28-I, a copy of which is to be maintained for public inspection in the office of the City Clerk and the City Traffic Engineer, and such other streets, parts of streets, or areas as may be added to said Schedule by resolution of the City Council, are declared to be public street segments where the operation of golf carts is permitted in accordance with the provisions of the Nevada Revised Statutes.

SECTION 3: Except in locations designated by Schedule 28-I, and except where crossing a public street at a marked and signed crossing authorized by the City Traffic Engineer, it shall be unlawful to operate a golf cart on any City street or right-of-way.

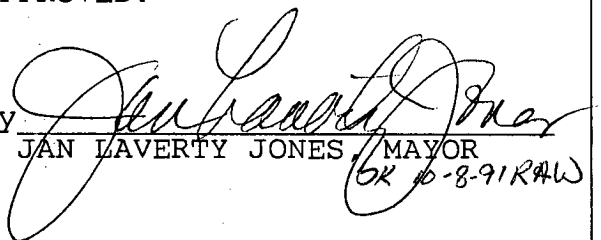
SECTION 4: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any

1 part thereof, is for any reason held to be unconstitutional or  
2 invalid or ineffective by any court of competent jurisdiction,  
3 such decision shall not affect the validity or effectiveness of  
4 the remaining portions of this ordinance or any part thereof.  
5 The City Council of the City of Las Vegas, Nevada, hereby  
6 declares that it would have passed each section, subsection, sub-  
7 division, paragraph, sentence, clause or phrase thereof irrespec-  
8 tive of the fact that any one or more sections, subsections, sub-  
9 divisions, paragraphs, sentences, clauses or phrases be declared  
10 unconstitutional, invalid or ineffective.

11 SECTION 5: All ordinances or parts of ordinances,  
12 sections, subsections, phrases, sentences, clauses or paragraphs  
13 contained in the Municipal Code of the City of Las Vegas, Nevada,  
14 1983 Edition, in conflict herewith are hereby repealed.
