

ORDINANCE NO. 684

AN ORDINANCE TO AMEND CHAPTER 24, SECTION 19, CODE OF LAS VEGAS, NEVADA, 1949, AS AMENDED BY ORDINANCE NO. 570 BY PROVIDING FOR PUBLIC OR SEMI PUBLIC PARKING AREAS IN AN R-4 USE DISTRICT; PROVIDING OTHER MATTERS RELATED THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH.

The Board of Commissioners of the City of Las Vegas do ordain as follows:

SECTION 1. Chapter 24, Section 19, Code of Las Vegas, Nevada, 1949, as amended by Ordinance No. 570 is further amended by adding a new sub paragraph to be designated A--8 (f) which shall read as follows:

Public or semi-public parking area for the use of patrons or residents in the immediate vicinity thereof when located and developed as required in Section 12 of this Chapter, provided that no buildings for such purpose shall be permitted for more than one story in height.

SECTION 2. All ordinances and parts of ordinances in conflict herewith are hereby repealed.

SECTION 3. This ordinance shall be in full force and effect upon its publication as in the next section provided, and final passage.

SECTION 4. The City Clerk and the Clerk of the Board of Commissioners of the City of Las Vegas shall cause this ordinance to be published once a week for two successive weeks immediately following its first reading and adoption in the Las Vegas Sun, a daily newspaper published in the City of Las Vegas.
