ORDINANCE NO. 5409

AN ORDINANCE TO INCREASE THE COMPENSATION PAYABLE TO MEMBERS OF THE PLANNING COMMISSION AS AUTHORIZED BY STATE LAW, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Summary: Increases the compensation payable to members of the Planning Commission as authorized by State law.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
AS FOLLOWS:

SECTION 1: Title 2, Chapter 44, Section 10, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

2.44.010: (A) There is created the City Planning Commission to consist of seven members appointed in accordance with LVMC 2.44.020 and NRS 278.040.

(B) Each member of the Planning Commission shall receive from the City, as and for compensation for his or her services thereon, the sum of [fifty] eighty dollars for each meeting of the Commission that he or she actually attends.

SECTION 2: This Ordinance shall be effective as of October 1, 2001.

SECTION 3: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

SECTION 4: All ordinances or parts of ordinances or sections, subsections, phrases,

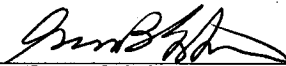

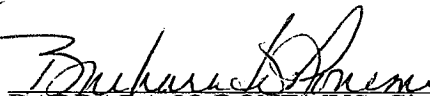

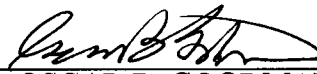

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
AS FOLLOWS:

SECTION 1: Title 2, Chapter 44, Section 10, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

2.44.010: (A) There is created the City Planning Commission to consist of seven members appointed in accordance with LVMC 2.44.020 and NRS 278.040.

(B) Each member of the Planning Commission shall receive from the City, as and for compensation for his or her services thereon, the sum of [fifty] eighty dollars for each meeting of the Commission that he or she actually attends.

SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. 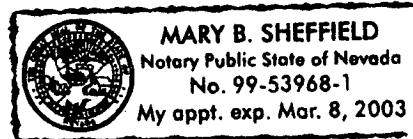

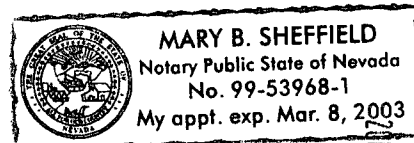
