ORDINANCE NO. 5455

AN ORDINANCE ESTABLISHING TEMPORARY EVENT BUSINESS LICENSING REQUIREMENTS, MERGING TRADE SHOW BUSINESS LICENSING REQUIREMENTS THEREIN, AND PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO.

Summary: Establishes temporary event business
licensing requirements.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
AS FOLLOWS:

SECTION 1: Title 6, Chapter 28, Section 10, of the Municipal Code of the City of
Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

6.28.010: [(A)] "Convention" means a meeting with an established agenda consisting of
speakers or other programs that address matters of concern to those attending the meeting. The
meeting may also include times and places at which convention exhibitors demonstrate, display, sell
or offer to sale goods or services that reasonably relate to the primary interests of the convention.

[(B)] "Convention exhibitor" means any person who sells, offers for sale or solicits
orders for the sale of goods or services on a temporary basis at a bona fide international, national, state
or local convention.

[(C)] "Convention operator" means any person who sponsors or organizes a
convention wherein space is provided for convention exhibitors.

"Temporary event" means any of the following events lasting for a limited time:

(1) A production, show, display, demonstration, exhibition or performance
of music, art, theater, dance and all other forms of fine art, performing art and cultural events;

(2) An open house where the public is charged a fee to attend; or

(3) An event featuring goods or services which exhibitors demonstrate,
display, sell or offer for sale.

"Temporary event exhibitor" means any person who sells, offers for sale or solicits
orders for the sale of goods or services at a temporary event.

1 “Temporary event operator” means any person who sponsors or organizes a temporary
2 event.

3 [(D) “Trade show” means a show featuring lines of reasonable related goods or
4 services which exhibitors demonstrate, display, sell or offer for sale. Gatherings of sellers of unrelated
5 merchandise are deemed not to be trade shows as defined by this Subsection.

6 (E) “Trade show exhibitor” means any person who sells, offers for sale or solicit
7 orders for the sale of goods or services on a temporary basis at a bona fide international, national, state
8 or local trade show or fair.

9 (F) “Trade show operator” means any person who sponsors or organizes a trade
10 show wherein space is provided for a trade show exhibitor.]

11 SECTION 2: Title 6, Chapter 28, Section 20, of the Municipal Code of the City of
12 Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

13 **6.28.020:** Excepted from the provisions of this Chapter and the licensing requirements of Title
14 6 is the sale, offer for sale or the solicitation of orders at a [trade show] temporary event or convention
15 where the attendance [at which] is restricted and where the general public is not [invited.] permitted.

16 SECTION 3: Title 6, Chapter 28, Section 30, of the Municipal Code of the City of
17 Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

18 **6.28.030:** No person shall act as a convention operator or [trade show operator] temporary event
19 operator at a convention or [trade show] temporary event which is open to the general public without
20 first obtaining and thereafter maintaining a valid unexpired license pursuant to this [Code.] Title.

21 SECTION 4: Title 6, Chapter 28, Section 40, of the Municipal Code of the City of
22 Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

23 **6.28.040:** The following conditions must be satisfied in order to qualify for a convention
24 operator’s or temporary event operator’s license:

25 (A) [The convention or trade show] Convention and temporary event exhibitors
26 may only be allowed to operate for [fourteen] thirty days or less at any one convention or [trade show]
27 temporary event.

28 (B) [The convention or trade show] A convention must be conducted at a publicly

owned convention [or other] facility, a hotel having one hundred fifty rooms or more, a public park or a commercial building having at least two hundred fifty thousand square feet.

SECTION 5: Title 6, Chapter 28, Section 50, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

6.28.050: [Each convention or trade show operator in applying for a license must:

(A) List the name and address of each exhibitor;

(B) Describe in general terms the goods or services offered by each exhibitor;

(C) Pay in advance a license fee in the amount of seven dollars per day for each exhibitor.]

Each convention operator or temporary event operator when applying for a license must:

(A) Describe specifically the event to be conducted including:

(1) The hours of the event;

(2) The admission costs to customers and attendees;

(3) The quantity of security to be present;

(4) The nature of the event; and

(5) A primary contact person for the event.

(B) List the name, address and telephone number of each exhibitor.

(C) Describe in general terms the goods or services offered by each exhibitor.

SECTION 6: Title 6, Chapter 28, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto a new Section, designated as Section 55, to read as follows:

6.28.055: (A) The license fee for a convention operator license is fifty dollars plus five dollars per day for each convention exhibitor, payable in advance.

(B) The license fee for a temporary event operator license is twenty-five dollars for each day of the event plus five dollars per day for each temporary event exhibitor, payable in advance.

SECTION 7: Title 6, Chapter 28, Section 60, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

6.28.060: Each license issued pursuant to this Chapter shall be limited to the days approved for

1 operation, not to exceed thirty days.

2 SECTION 8: Title 6, Chapter 28, Section 70, of the Municipal Code of the City of
3 Las Vegas, Nevada, 1983 Edition, is hereby repealed.

4 SECTION 9: If any section, subsection, subdivision, paragraph, sentence, clause or
5 phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid
6 or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
7 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
8 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
9 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
10 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
11 invalid or ineffective.

12 SECTION 10: Whenever in this ordinance any act is prohibited or is made or declared
13 to be unlawful or an offense or a misdemeanor, or whenever in this ordinance the doing of any act is
14 required or the failure to do any act is made or declared to be unlawful or an offense or a
15 misdemeanor, the doing of such prohibited act or the failure to do any such required act shall
16 constitute a misdemeanor and upon conviction thereof, shall be punished by a fine of not more than
17 \$1,000.00 or by imprisonment for a term of not more than six months, or by any combination of such
18 fine and imprisonment. Any day of any violation of this ordinance shall constitute a separate offense.

19 SECTION 11: All ordinances or parts of ordinances or sections, subsections, phrases,
20 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,

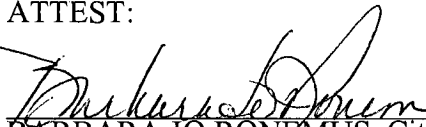

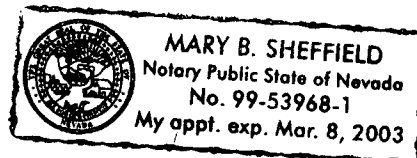

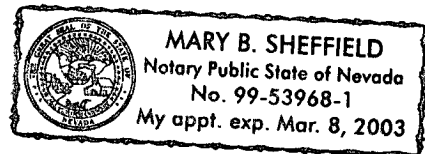
