ORDINANCE NO. 5452

AN ORDINANCE AMENDING THE BUSINESS LICENSING REQUIREMENTS FOR ARTS AND CRAFTS SHOWS; AND PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO.

Summary: Amends the business licensing requirements for arts and crafts shows.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
AS FOLLOWS:

SECTION 1: Title 6, Chapter 11, Section 10, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

[(A)] "Arts and crafts show" means a show [at which] where arts and crafts are displayed or sold, or both[.] displayed and sold. An arts and crafts show may also include vendors as defined in this Section, but only in accordance with Section 6.11.050.

[(B)] "Arts and crafts" means the handiwork of human beings in color, wood, leather, plastic, glass, cloth or [similar] other materials to produce [an] a non-consumable article which [is beautiful in visible form, or useful, or ornamental to please the eye and gratify the taste,] has decorative appeal and which is not manufactured in a plant or factory.

[(C)] "Exhibitor" means [the artist who painted, made, created or produced the arts and crafts article and whose booth is included in computing the fee for the arts and crafts show pursuant to Section 6. 11.020.] a person who:

(A) Has created, made or produced arts and crafts articles; and

(B) Displays, sells, or both displays and sells, such articles at an arts and crafts show.

"Vendor" means any person (other than an exhibitor) who, at an arts and crafts show, displays, sells or offers services, goods or items other than arts and crafts.

SECTION 2: Title 6, Chapter 11, Section 20, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

1 **6.11.020:** [The license fee for each arts and crafts show is twenty-five dollars plus one dollar per
2 exhibitor's booth in the arts and crafts show.]

3 (A) Each applicant for an arts and crafts show license shall pay a thirty dollar
4 application processing fee.

5 (B) The license fee for each arts and crafts show shall be:

6 (1) Twenty-five dollars daily for up to twenty-five exhibitors (or
7 combination of exhibitors and vendors).

8 (2) Fifty dollars daily for twenty-six up to one hundred exhibitors (or
9 combination of exhibitors and vendors).

10 (3) One hundred dollars daily for one-hundred one or more exhibitors (or
11 combination of exhibitors and vendors).

12 SECTION 3: Title 6, Chapter 11, Section 30, of the Municipal Code of the City of
13 Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

14 **6.11.030:** Each exhibitor's booth in an arts and crafts show must be operated and managed by
15 the exhibitor or by the exhibitor's agent or representative [as evidenced by a power of attorney].

16 SECTION 4: Title 6, Chapter 11, Section 50, of the Municipal Code of the City of
17 Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

18 **6.11.050:** [No article may be displayed or sold at an arts and crafts show which has been
19 previously sold or owned by any person other than the exhibitor.]

20 (A) No arts and crafts article may be displayed or sold at an arts and crafts show
21 except by the exhibitor who created the article or by an agent or representative of the exhibitor.

22 (B) No exhibitor, or agent or representative of the exhibitor, may display or sell at
23 an arts and crafts show any item which was previously owned by, or sold on behalf of, any person
24 other than the exhibitor unless the exhibitor materially altered the item in order to incorporate it into
25 an arts and crafts article.

26 (C) An arts and crafts show may include vendors as well as exhibitors, but only if,
27 at any given time, the number of exhibitors exceeds the number of vendors.

28 SECTION 5: Title 6, Chapter 11, of the Municipal Code of the City of Las Vegas,

1 Nevada, 1983 Edition, is hereby amended by adding thereto a new Section, designated as Section 60,
2 to read as follows:

3 **6.11.060:** (A) The licensee of each arts and crafts show conducted outdoors on private
4 property must post proof at such location of a temporary commercial permit issued by the Planning
5 and Development Department.

6 (B) The licensee of each arts and crafts show conducted outdoors at a park or other
7 public place owned by the City must first have contracted with the City for permission to conduct the
8 show.

9 SECTION 6: Title 6, Chapter 11, of the Municipal Code of the City of Las Vegas,
10 Nevada, 1983 Edition, is hereby amended by adding thereto a new Section, designated as Section 70,
11 to read as follows:

12 **6.11.070:** In the case of any arts and crafts show conducted at a publicly owned convention
13 center, a hotel having one hundred fifty rooms or more or a commercial building having at least two
14 hundred fifty thousand square feet, the provisions of LVMC Chapter 6.28 shall apply rather than the
15 provisions of this Chapter.

16 SECTION 7: If any section, subsection, subdivision, paragraph, sentence, clause or
17 phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid
18 or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
19 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
20 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
21 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
22 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
23 invalid or ineffective.

24 SECTION 8: All ordinances or parts of ordinances or sections, subsections, phrases,
25 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,

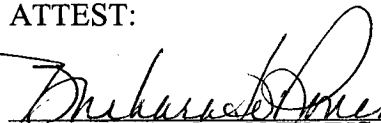

AN ORDINANCE AMENDING THE BUSINESS LICENSING REQUIREMENTS FOR ARTS AND CRAFTS SHOWS; AND PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO.

Summary: Amends the business licensing requirements for arts and crafts shows.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
AS FOLLOWS:

SECTION 1: Title 6, Chapter 11, Section 10, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

[(A)] "Arts and crafts show" means a show [at which] where arts and crafts are displayed or sold, or both[.] displayed and sold. An arts and crafts show may also include vendors as defined in this Section, but only in accordance with Section 6.11.050.

[(B)] "Arts and crafts" means the handiwork of human beings in color, wood, leather, plastic, glass, cloth or [similar] other materials to produce [an] a non-consumable article which [is beautiful in visible form, or useful, or ornamental to please the eye and gratify the taste,]has decorative appeal and which is not manufactured in a plant or factory.

[(C)] "Exhibitor" means [the artist who painted, made, created or produced the arts and crafts article and whose booth is included in computing the fee for the arts and crafts show pursuant to Section 6. 11.020.] a person who:

(A) Has created, made or produced arts and crafts articles; and

(B) Displays, sells, or both displays and sells, such articles at an arts and crafts show.

"Vendor" means any person (other than an exhibitor) who, at an arts and crafts show, displays, sells or offers services, goods or items other than arts and crafts.

SECTION 2: Title 6, Chapter 11, Section 20, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

6.11.020: [The license fee for each arts and crafts show is twenty-five dollars plus one dollar per

exhibitor's booth in the arts and crafts show.]

(A) Each applicant for an arts and crafts show license shall pay a thirty dollar application processing fee.

(B) The license fee for each arts and crafts show shall be:

(1) Twenty-five dollars daily for up to twenty-five exhibitors (or combination of exhibitors and vendors).

(2) Fifty dollars daily for twenty-six up to one hundred exhibitors (or combination of exhibitors and vendors).

(3) One hundred dollars daily for one-hundred one or more exhibitors (or combination of exhibitors and vendors).

SECTION 3: Title 6, Chapter 11, Section 30, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

6.11.030: Each exhibitor's booth in an arts and crafts show must be operated and managed by the exhibitor or by the exhibitor's agent or representative [as evidenced by a power of attorney].

SECTION 4: Title 6, Chapter 11, Section 50, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

6.11.050: [No article may be displayed or sold at an arts and crafts show which has been previously sold or owned by any person other than the exhibitor.]

(A) No arts and crafts article may be displayed or sold at an arts and crafts show except by the exhibitor who created the article or by an agent or representative of the exhibitor.

(B) No exhibitor, or agent or representative of the exhibitor, may display or sell at an arts and crafts show any item which was previously owned by, or sold on behalf of, any person other than the exhibitor unless the exhibitor materially altered the item in order to incorporate it into an arts and crafts article.

(C) An arts and crafts show may include vendors as well as exhibitors, but only if, at any given time, the number of exhibitors exceeds the number of vendors.

SECTION 5: Title 6, Chapter 11, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto a new Section, designated as Section 60,

1 to read as follows:

2 **6.11.060:** (A) The licensee of each arts and crafts show conducted outdoors on private
3 property must post proof at such location of a temporary commercial permit issued by the Planning
4 and Development Department.

5 (B) The licensee of each arts and crafts show conducted outdoors at a park or other
6 public place owned by the City must first have contracted with the City for permission to conduct the
7 show.

8 SECTION 6: Title 6, Chapter 11, of the Municipal Code of the City of Las Vegas,
9 Nevada, 1983 Edition, is hereby amended by adding thereto a new Section, designated as Section 70,
10 to read as follows:

11 **6.11.070:** In the case of any arts and crafts show conducted at a publicly owned convention
12 center, a hotel having one hundred fifty rooms or more or a commercial building having at least two
13 hundred fifty thousand square feet, the provisions of LVMC Chapter 6.28 shall apply rather than the
14 provisions of this Chapter.

15 SECTION 7: If any section, subsection, subdivision, paragraph, sentence, clause or
16 phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid
17 or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
18 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
19 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
20 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
21 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
22 invalid or ineffective.

23 SECTION 8: All ordinances or parts of ordinances or sections, subsections, phrases,

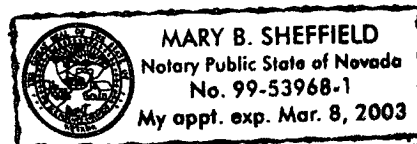

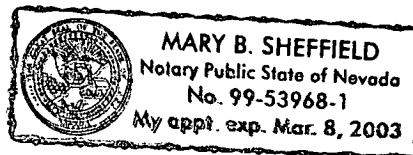
