AN ORDINANCE RELATING TO ANIMAL CARE AND CONTROL; AMENDING TITLE 7, CHAPTERS 4 AND 8 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION AND ORDINANCE NO. 3618 ADOPTED BY THE CITY COUNCIL OF THE CITY OF LAS VEGAS TO ALLOW A PERSON TO OWN, KEEP OR POSSESS UP TO SIX SPAYED OR NEUTERED DOGS OR TWELVE SPAYED OR NEUTERED CATS UPON HIS OR HER PROPERTY PROVIDED THAT PERSON OBTAINS A PET FANCIER'S PERMIT; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HERewith.

Summary: Amendment to the LVMC Chapters 7.04 and 7.08 and Ordinance No. 3618 adopted December 4, 1991, to allow a person to own, keep or possess up to six (6) sterilized dogs or twelve sterilized cats, or combination thereof, if that person obtains a pet fancier's permit.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
ORDAIN AS FOLLOWS:

SECTION 1: Title 7, Chapter 4 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition and Ordinance No. 3618 adopted by the City Council of the City of Las Vegas on December 4, 1991, are hereby amended by adding thereto Section 2 of this Ordinance.

SECTION 2: "Pet Fancier" means any person owning, keeping or possessing on his or her property, up to six spayed or neutered dogs over one year of age or twelve spayed or neutered cats over eight months of age, or combination thereof.

SECTION 3: Title 7, Chapter 8 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition and Ordinance No. 3618 adopted by the City Council of the City of Las Vegas on December 4, 1991, are hereby amended by adding thereto Section 4 of this Ordinance.

SECTION 4: A pet fancier may own, keep or possess on his or her property not more than six spayed or neutered dogs over one year of age or twelve spayed or neutered cats over eight months of age, or any combination thereof if the number of dogs

1 does not exceed six and the combined number of animals does not
2 exceed twelve, provided that the pet fancier has obtained from
3 the Animal Regulation Officer a pet fancier's permit. The pet
4 fancier shall obtain a pet fancier's permit from the Animal
5 Regulation Officer each and every twelve month period. The
6 Animal Regulation Officer shall issue the pet fancier's permit
7 only after inspecting the applicant's property and determining
8 that the dogs or cats, or both, will be safely confined in a
9 completely enclosed building, residence or enclosed lot and do
10 not pose a nuisance to the public. As a part of the application
11 process, the Animal Control Officer shall notify all property
12 owners contiguous to the applicant's property that the applicant
13 has applied for a pet fancier's permit. The cost of the inspec-
14 tion and permit shall be fifty dollars. A pet fancier who has
15 obtained a pet fancier's permit need not have his or her property
16 rezoned for the purpose of owning, keeping or possessing such
17 pets.

18 SECTION 5: If any section, subsection, subdivision,
19 paragraph, sentence, clause or phrase in this ordinance or any
20 part thereof is for any reason held to be unconstitutional or
21 invalid or ineffective by any court of competent jurisdiction,
22 such decision shall not affect the validity or effectiveness of
23 the remaining portions of this ordinance or any part thereof.
24 The City Council of the City of Las Vegas, Nevada, hereby
25 declares that it would have passed each section, subsection, sub-
26 division, paragraph, sentence, clause or phrase thereof
27 irrespective of the fact that any one or more sections, subsec-
28 tions, subdivisions, paragraphs, sentences, clauses, or phrases
29 be declared unconstitutional, invalid or ineffective.

30 SECTION 6: All ordinances or parts of ordinances, sec-
31 tions, subsections, phrases, sentences, clauses or paragraphs
32 contained in the Municipal Code of the City of Las Vegas, Nevada,

in conflict herewith are hereby repealed.

Summary: Amendment to Ordinance No. 3618 adopted December 4, 1991, to allow a person to own, keep or possess six (6) sterilized dogs or twelve sterilized cats if that person obtains a pet fancier's permit.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
ORDAIN AS FOLLOWS:

SECTION 1: Ordinance No. 3618 adopted by the City Council of the City of Las Vegas on December 4, 1991, is hereby amended by adding thereto sections 2 through 3 of this Ordinance.

SECTION 2: "Pet Fancier" means any person owning, keeping or possessing on his or her property, up to six spayed or neutered dogs over one year of age or sixteen spayed or neutered cats over eight months of age.

SECTION 3: A pet fancier may own, keep or possess on his or her property not more than six spayed or neutered dogs over one year of age or twelve spayed or neutered cats over eight months of age, or any combination thereof if the number of dogs does not exceed six and the combined number of animals does not exceed twelve, provided that the pet fancier has obtained from the Animal Regulation Officer a pet fancier's permit. The pet fancier shall obtain a pet fancier's permit from the Animal Regulation Officer each and every twelve month period. The Animal Regulation Officer shall issue the pet fancier's permit only after inspecting the applicant's property and determining that the dogs or cats, or both, will be safely confined in a

1 completely enclosed building, residence or enclosed lot and do
2 not pose a nuisance to the public. The cost of the inspection
3 and permit shall be fifty dollars. A pet fancier who has
4 obtained a pet fancier's permit need not have his or her property
5 rezoned for the purpose of owning, keeping or possessing such
6 pets.

7 SECTION 4: If any section, subsection, subdivision,
8 paragraph, sentence, clause or phrase in this ordinance or any

Summary: Amendment to Ordinance No. 3618 adopted December 4, 1991, to allow a person to own, keep or possess six (6) sterilized dogs or sixteen (16) sterilized cats if that person obtains a pet fancier permit.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
ORDAIN AS FOLLOWS:

SECTION 1: Ordinance No. 3618 adopted by the City Council of the City of Las Vegas on December 4, 1991, is hereby amended by adding thereto sections 2 through 3 of this Ordinance.

SECTION 2: "Pet Fancier" means any person owning, keeping or possessing on his property, properly confined or restrained, up to six spayed or neutered dogs over one year of age or sixteen spayed or neutered cats over eight months of age.

SECTION 3: A pet fancier may own, keep or possess on his property not more than six spayed or neutered dogs over one year of age or sixteen spayed or neutered cats over eight months of age, provided that the pet fancier obtains from the Animal Regulation Officer a pet fancier permit at an annual fee of twenty-five dollars, which cost shall include inspection. If granted, the permit shall be on such conditions as may be deemed necessary or advisable by the Animal Regulation Officer or the Health Officer to prevent such animals from becoming a nuisance. The limit on the number of animals may be increased if the Animal Regulation Officer determines that the increase is appropriate to the pet fanciers facilities and premises and does not involve a threat to the health, safety and welfare of the public or to the

1 other animals already owned, kept and possessed thereon. Pet
2 fanciers meeting the provisions of this Section and having a pet
3 fanciers permit need not have the property where the animals are
4 so kept and maintained rezoned.

5 SECTION 4: If any section, subsection, subdivision,
6 paragraph, sentence, clause or phrase in this ordinance or any
7 part thereof is for any reason held to be unconstitutional or
8 invalid or ineffective by any court of competent jurisdiction,
9 such decision shall not affect the validity or effectiveness of
10 the remaining portions of this ordinance or any part thereof.

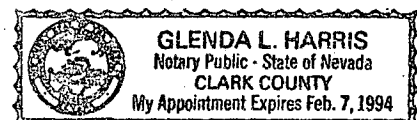

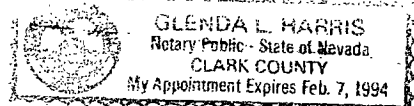
