ORDINANCE NO. 3685

AN ORDINANCE RELATING TO THE AMENDED REGULATIONS FOR THE CONTROL OF DRAINAGE; AMENDING TITLE 20, CHAPTER 10, SECTION 10, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, WHICH WILL PROVIDE THAT THE AMENDED UNIFORM REGULATIONS FOR THE CONTROL OF DRAINAGE AMENDED AND APPROVED ON AUGUST 13, 1992, BY THE CLARK COUNTY REGIONAL FLOOD CONTROL DISTRICT BOARD OF DIRECTORS IS INCORPORATED INTO THE CITY CODE.

Sponsored By: Mayor Jan Laverty Jones Summary: Amends LVMC 20.10.010 to incorporate recent amendments to the Uniform Regulations for the Control of Drainage.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 20, Chapter 10, Section 10, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

20.10.010: That certain document, three copies of which being on file in the office of the City Clerk and designated as follows, is adopted by reference and made a part of this Code, to the same effect as if set forth at length herein: The Uniform Regulations for the Control of Drainage, promulgated by the Clark County Regional Flood Control District and approved on [September 13, 1990.] August 13, 1992.

SECTION 2: Whenever in this ordinance any act is prohibited or is made or declared to be unlawful or an offense or a misdemeanor, or whenever in this ordinance the doing of any act is required or the failure to do any act is made or declared to be unlawful or an offense or a misdemeanor, the doing of any such prohibited act or the failure to do any such required act shall constitute a misdemeanor and upon conviction thereof, shall be punished by a fine of not more than \$1,000.00 or by imprisonment for a term of not more than six (6) months, or by any combination of such fine and imprisonment. Any day of any violation of this ordinance shall constitute a separate offense.



SECTION 3: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas, Nevada, hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

SECTION 4: All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, in conflict herewith are hereby repealed.
