THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 3, Chapter 4, Section 10, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

3.04.010: A certain document, three copies of which are on file in the Office of the Clerk and designated as the Civil Service Rules, as revised and approved by the Civil Service Board on June 22, 1992, is hereby adopted by reference and made a part of this chapter as if the same [was] were fully set forth herein.

SECTION 2: If any section, subsection, subdivision paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas, Nevada, hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be

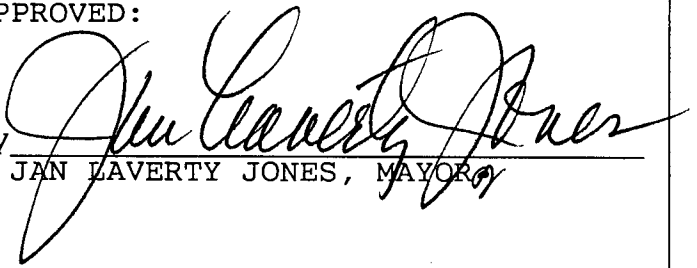
1 declared unconstitutional, invalid or ineffective.

5 1983 Edition, in conflict herewith are hereby repealed.

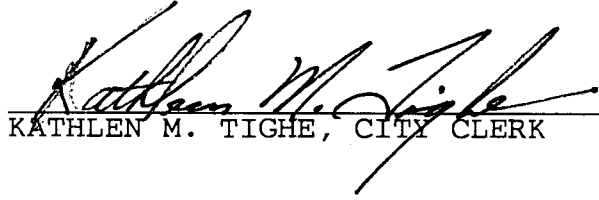
