ORDINANCE No. 2294

AN ORDINANCE RELATING TO PUBLIC DANCES; REQUIRING A PERMIT FOR PERSONS SPONSORING A PUBLIC DANCE; ESTABLISHING CERTAIN STANDARDS AND REGULATIONS FOR THE CONDUCT OF PUBLIC DANCES; SETTING PERMIT FEES; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; PROVIDING PENALTIES FOR THE VIOLATION THEREOF; AND REPEALNG ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Revises chapter on dancehalls as a part of recodification.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Chapter 34 of Title V of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby repealed.

SECTION 2: Title V of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to add a new Chapter 34 to read as follows:

5-34-1: It is unlawful for any person to advertise or conduct a public dance where an admission is charged without a valid unexpired permit as provided in this chapter. This section does not apply to a dance sponsored by an educational or religious institution or a dance approved as a charitable event pursuant to LVC Title V, Chapter 13.

5-34-2: The application shall be made on forms suitable to the Director and filed with the Department at least 10 days prior to the event. The application shall set forth the following information:

- (A) The name and address of the person sponsoring the dance.
- (B) The date and times for which the dance will be conducted.
- (C) The name and address of the person providing the music.
- (D) A description of the dancehall, including measurements for seating and dancing areas, and the illumination of the dancehall.

1 (E) Provisions made by the applicant for security and the names
2 and addresses of the persons who will be supervising the con-
3 duct of the dance.

4 (F) The admission fees and the number of tickets to be distrib-
5 uted to the public.

6 (G) The type and extent of the promotional advertising.

7 (H) Such other information as required by the Director as relates
8 to the security and conduct of the dance.

9 5-34-3: Upon receipt of the application, the Director may have
10 the same considered by various departments or agencies such as
11 the Las Vegas Metropolitan Police Department, Fire Department and
12 the Building and Safety Department for their consideration and
13 approval. Upon completion of the review of the application, the
14 Director shall approve, deny or take such other action with
15 respect to such application as he considers appropriate. The
16 Director in approving a permit may set such conditions as he
17 determines is required for the health, safety and general welfare
18 of the public. The Director may deny, revoke or suspend a permit
19 for good cause which includes but is not limited to:

20 (A) The application is incomplete or contains false, misleading
21 or fraudulent statements with respect to any information
22 required.

23 (B) The proposed public dance would interfere with the health,
24 safety or general welfare of the public or constitute a
25 breach of peace.

26 (C) The proposed public dance fails to satisfy any qualification
27 or requirement imposed by this Code, or other local, state or
28 federal law or regulation pertaining to such activities.

29 (D) The applicant fails to comply with any conditions of the
30 permit.

31 5-34-4: It is unlawful for a permittee or other person conducting

1 or supervising a public dance to knowingly permit or allow any
2 person to commit an act upon the premises which is a violation of
3 local, state or federal law.

4 5-34-5: It is unlawful for any public dance sponsored for minors
5 to continue later than one-half hour before curfew.

6 5-34-6: (A) It is unlawful for any person to sponsor, conduct
7 or supervise a public dance where dancing partners may be
8 obtained for the payment of any consideration.

9 (B) It is unlawful for any person in or about any dancehall or
10 other place where public dancing is conducted to solicit
11 another person to be a dancing partner for the payment of any
12 consideration.

13 5-34-7: Each person required to have a permit shall pay in
14 advance a permit fee of \$25 for each day or part thereof of the
15 public dance. Excepting, however, that such fee is not required
16 to be paid by a person who already holds a valid City business
17 license for the premises wherein the public dance is to be con-
18 ducted.

19 SECTION 3: If any section, subsection, subdivision,
20 paragraph, sentence, clause or phrase in this Chapter or any part
21 thereof, is for any reason held to be unconstitutional or invalid
22 or ineffective by any court of competent jurisdiction, such deci-
23 sion shall not affect the validity or effectiveness of the
24 remaining portions of this Chapter or any part thereof. The
25 Board of Commissioners of the City of Las Vegas, Nevada, hereby
26 declares that it would have passed each section, subsection, sub-
27 division, paragraph, sentence, clause or phrase thereof irrespec-
28 tive of the fact that any one or more sections, subsections,
29 subdivisions, paragraphs, sentences, clauses or phrases be
30 declared unconstitutional, invalid or ineffective.

31 SECTION 4: Whenever in this ordinance any act is
32 prohibited or is made or declared to be unlawful or an offense or

1 a misdemeanor, the doing of any such prohibited act or the
2 failure to do any such required act shall constitute a mis-
3 demeanor and upon conviction thereof, shall be punished by a fine
4 of not more than \$1,000.00 or by imprisonment for a term of not
5 more than Six (6) Months, or by any combination of such fine and
6 imprisonment. Any day of any violation of this ordinance shall
7 constitute a separate offense.

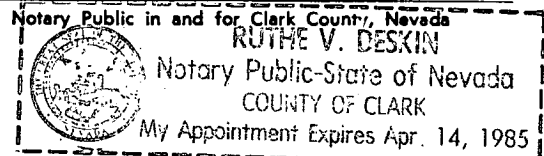

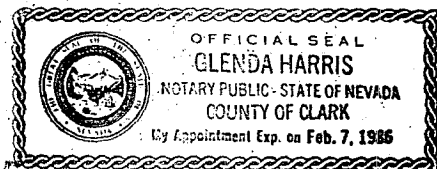

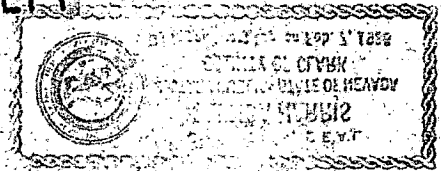
