3 AN ORDINANCE RELATING TO LIQUOR CONTROL; AMENDING TITLE V, CHAPTER
4 18, SECTION 15, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS,
5 NEVADA, 1960 EDITION, AS LAST AMENDED BY ORDINANCE NO. 2257 OF
6 SAID CITY, TO REPEAL THAT PORTION OF SAID SECTION 15 WHICH RE-
7 QUIRES THAT A SEPARATE CHECK-OUT STAND AND CASH REGISTER BE
8 PROVIDED FOR THE SELF-SERVICE SALE OF ALCOHOLIC BEVERAGES; PRO-
9 VIDING OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING
10 ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

16 THE BOARD OF CITY COMMISSIONERS OF THE CITY OF LAS
17 VEGAS, NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

18 SECTION 1: Title V, Chapter 18, Section 15 of the
19 Municipal Code of the City of Las Vegas, Nevada, 1960 Edition,
20 as last amended by Ordinance No. 2257 of said City, is hereby
21 amended to read as follows:

22 5-18-15: Whenever an "off sale" of alcoholic beverages is made,
23 the alcoholic beverages, except beer and wine, must only
24 be displayed for sale in an area of the licensed
25 premises in which such alcoholic beverages are not
26 accessible by persons under the age of 21 years. This
27 area must be kept under the exclusive control of a
28 person who is at least 21 years of age. When self
29 service of alcoholic beverages, except beer and wine, is
30 provided, the area in which the alcoholic beverages are
31 displayed must be partitioned from the rest of the
32 premises [and a separate check-out stand and cash register
must be provided.]; provided, however, that such alco-
holic beverages may be selected by the customer and
purchased at a common check-out stand at which non-
alcoholic beverages may be purchased. No self-service
shall be permitted in original sealed or corked con-

1 tainers in quantities less than one pint, measured in
2 the English system of weights and measures, or in quan-
3 tities less than four hundred milliliters, measured in
4 the metric system of weights and measures.

5 SECTION 2: If any section, subsection, subdivision,
6 paragraph, sentence, clause or phrase in this Chapter or any part
7 thereof, is for any reason held to be unconstitutional or invalid
8 or ineffective by any court of competent jurisdiction, such de-
9 cision shall not affect the validity or effectiveness of the
10 remaining portions of this Chapter or any part thereof. The Board
11 of City Commissioners of the City of Las Vegas, Nevada, hereby
12 declares that it would have passed each section, subsection, sub-
13 division, paragraphs, sentence, clause or phrase thereof, irrespec-
14 tive of the fact that any one or more sections, subsections,
15 subdivisions, paragraphs, sentences, clauses or phrases be declared
16 unconstitutional, invalid or ineffective.

17 SECTION 3: All ordinances or parts of ordinances,
18 sections, subsections, phrases, sentences, clauses or paragraphs
19 contained in the Municipal Code of the City of Las Vegas, Nevada,
20 1960 Edition, in conflict herewith are hereby repealed.

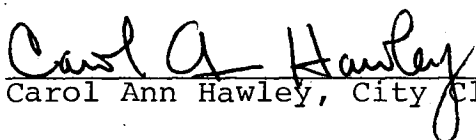

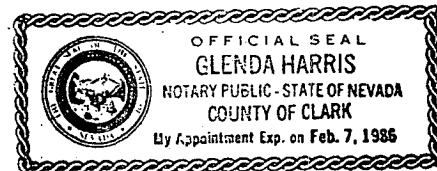

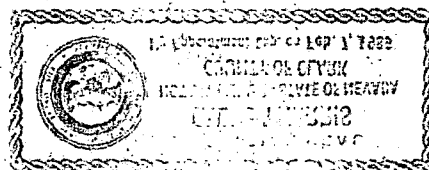
