ORDINANCE No. 2298

AN ORDINANCE RELATING TO UNLAWFUL IDENTIFICATION; PROHIBITING THE PRINTING, DESIGNING, MANUFACTURING, PRODUCING OR SELLING OF ANY FALSE, FRAUDULENT, MISLEADING OR FICTITIOUS IDENTIFICATION MATERIAL; PROHIBITING THE GIVING OF INFORMATION TO OBTAIN IDENTIFICATION MATERIAL WHICH IS FALSE, FRAUDULENT, MISLEADING OR FICTITIOUS; PROHIBITING THE INTENTIONAL USE OF FALSE, FRAUDULENT, MISLEADING OR FICTITIOUS IDENTIFICATION MATERIAL; REPEALING ORDINANCES IN CONFLICT HERewith; PROVIDING PENALTIES FOR VIOLATIONS HEREOF; AND PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO.

Summary: Revises chapter of the City Code which relates to unlawful identification, as a part of the recodification project, and transfers such provisions from Title V (Business Regulations) to Title VI (Police Regulations).

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS,
NEVADA DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Chapter 38 of Title V of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby repealed.

SECTION 2: Chapter 1 of Title VI of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to add a new Section to read as follows:

1. For the purposes of this Section, "identification material" is hereby defined to mean any card, paper, tag, badge, or any printed, stamped or engraved material whatsoever, which purports to confer upon an individual a particular status, occupation, membership, license or identity.

2. It is unlawful for any person engaged in the business of printing, designing, manufacturing, producing or selling identification material to knowingly print, design, manufacture, produce or sell any identification material which is false, fraudulent or fictitious or which would tend to deceive or mislead any person, or which would purport to confer upon an individual a particular status, occupation, license or identify which he does not in fact possess.

1 3. It is unlawful for any person to provide to another
2 person in the business of printing, designing, manufacturing,
3 producing or selling identification material any false, fraudu-
4 lent, misleading or fictitious information for the purpose of
5 acquiring any identification material which would be false,
6 fraudulent, misleading or fictitious.

7 4. It is unlawful for any person to knowingly use or
8 attempt to use any false, fraudulent, misleading or fictitious
9 identification material in order to obtain any privilege, benefit
10 or gratuity whatsoever.

11 SECTION 3: If any section, subsection, subdivision,
12 paragraph, sentence, clause or phrase in this Chapter or any part
13 thereof, is for any reason held to be unconstitutional or invalid
14 or ineffective by any court of competent jurisdiction, such deci-
15 sion shall not affect the validity or effectiveness of the
16 remaining portions of this Chapter or any part thereof. The
17 Board of Commissioners of the City of Las Vegas, Nevada, hereby
18 declares that it would have passed each section, subsection, sub-
19 division, paragraph, sentence, clause or phrase thereof irrespec-
20 tive of the fact that any one or more sections, subsections,
21 subdivisions, paragraphs, sentences, clauses or phrases be
22 declared unconstitutional, invalid or ineffective.

23 SECTION 4: Whenever in this ordinance any act is
24 prohibited or is made or declared to be unlawful or an offense or
25 a misdemeanor, the doing of any such prohibited act or the
26 failure to do any such required act shall constitute a mis-
27 demeanor and upon conviction thereof, shall be punished by a fine
28 of not more than \$1,000.00 or by imprisonment for a term of not
29 more than Six (6) Months, or by any combination of such fine and

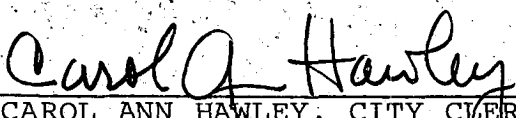

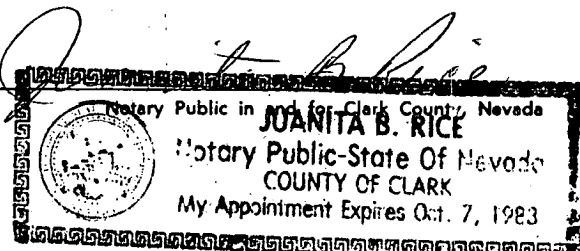
