ORDINANCE NO. 3000

AN ORDINANCE AMENDING TITLE X, CHAPTER 17, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, TO PROVIDE FOR THE ELIMINATION OF REGULATIONS RELATING TO THE STOPPING, STANDING OR PARKING OF VEHICLES THAT ARE EITHER DUPLICATIVE OF, OR ARE IN CONFLICT WITH, STATE LAW; AND PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO.

Purpose: Eliminates the provisions of the City Code which relate to the stopping, standing or parking of motor vehicles that are either duplicative of or are in conflict with, state law.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title X, Chapter 17, Sections 3, 5, 11, 13, 14, 15, 16, 17 and 31 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, are hereby repealed in their entirety.

SECTION 2: Title X, chapter 17, Section 1 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

10-17-1: No person shall stand or park a vehicle in a roadway other than parallel with the edge of the roadway headed in the direction of lawful traffic movement and with the [right-hand] wheels of the vehicle within [twelve inches (12")] eighteen inches (18") of the curb or edge of the roadway except as otherwise provided in this Chapter.

SECTION 3: Title X, Chapter 17, Section 12 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

10-17-12: (A) When signs are posted giving notice thereof, no

1 person shall stop, stand or park a vehicle, other
2 than a commercial vehicle actually engaged in
3 loading or unloading merchandise, in any alley
4 described in Schedule 17-I, a copy of which is to
5 be maintained for public inspection in the office
6 of the City Clerk and the City Traffic Engineer,
7 and such other alleys as may be added to said
8 schedule by resolution of the Board of Commissioners.

9 (B) [Any other Sections of this Chapter notwithstand-
10 ing, when] When signs are posted giving notice
11 thereof, no person shall park a vehicle at any
12 time in alleys or portions thereof described in
13 Schedule 17-II, a copy of which is to be maintained
14 for public inspection in the office of the City
15 Clerk and the City Traffic Engineer, and such
16 other alleys as may be added to said schedule by
17 resolution of the Board of Commissioners.

18 (C) A vehicle lawfully parked in an alley shall not
19 park for a greater period than thirty (30) minutes
20 at any time.

21 SECTION 4: Title X, Chapter 17, Section 18, Subsection
22 (B) of the Municipal Code of the City of Las Vegas, Nevada, 1960
23 Edition, is hereby repealed in its entirety.

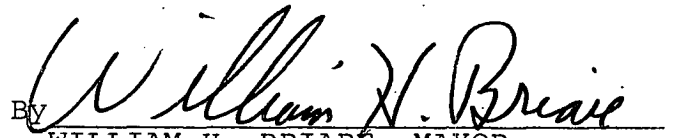
24 SECTION 5: This ordinance shall become effective on
25 October 1, 1982.

26 SECTION 6: If any section, subsection, subdivision,
27 paragraph, sentence, clause or phrase in this Chapter or any part
28 thereof, is for any reason held to be unconstitutional or invalid
29 or ineffective by any court of competent jurisdiction, such deci-
30 sion shall not affect the validity or effectiveness of the re-
31 maining portions of this Chapter or any part thereof. The Board
32 of Commissioners of the City of Las Vegas, Nevada, hereby declares

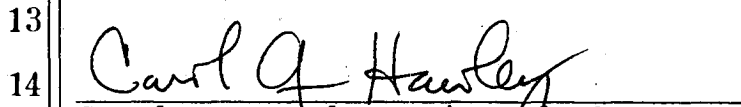
1 that it would have passed each section, subsection, subdivision,
2 paragraph, sentence, clause or phrase thereof irrespective of the
3 fact that any one or more sections, subsections, subdivisions,
4 paragraphs, sentences, clauses or phrases be declared uncon-
5 stitutional, invalid or ineffective.

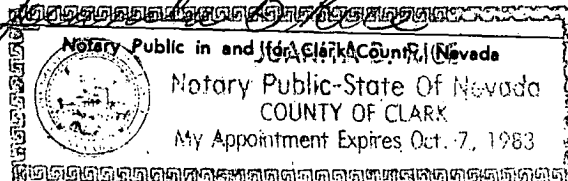
