4 AN ORDINANCE RELATING TO BUSINESS LICENSES, ESTABLISHING SEMI-  
5 ANNUAL LICENSE FEES FOR THE BUSINESS OF ACUPUNCTURE, REAL ESTATE  
6 APPRAISER, CREDIT BUREAU AND SERVICES-TECHNICAL AND MISCELLANEOUS;  
7 PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING  
8 ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

9 Sponsored by Summary: Establishes semi-annual  
10 Commissioner Ron Lurie license fees for the business of  
11 acupuncture, real estate appraiser,  
12 credit bureau and services-techni-  
13 cal and miscellaneous.

14 THE BOARD OF CITY COMMISSIONERS OF THE CITY OF LAS  
15 VEGAS, NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

16 SECTION 1: Title V, Chapter 1(A), Section 3 of the  
17 Municipal Code of the City of Las Vegas, Nevada, 1960 Edition,  
18 is hereby amended to read as follows:

19 5-1(A)-3:

20 (A) Accountant: \$50.00 semi-annually. Accountant shall  
21 mean each certified public accountant and public  
22 accountant registered and issued a permit under  
23 N.R.S. 628 and conducting a private practice, whether  
24 as a sole practitioner or as a partner or associate in  
25 a firm, and whether the practice is full-time or supple-  
26 mentary to employment with a Federal, State or local  
27 government agency.

28 (B) Acupuncture: \$50.00 semi-annually for each person  
29 practicing acupuncture whether a sole practitioner or  
30 a member or employee of a firm.

31 [(B)] (C) Adult Group Care Facility: \$50.00 semi-annually for  
32 each adult group care facility as defined by LVC 7-7-1  
of this Code after a license has been granted by the  
appropriate State and County Health Departments.

[(C)] (D) Advertising Business: \$50.00 semi-annually for each  
advertising business or advertising counsel.

1 [(D)] (E) Advertising Space - Leasing or Selling: \$250.00  
2 semi-annually for the business of leasing or selling  
3 outdoor advertising space whether on billboard or  
4 electrical signs, if such business is not required to  
5 have a contractor's license.

6 [(E)] (F) Ambulances: See LVC Title V, Chapter 28 for fees and  
7 regulations.

8 [(F)] (G) Apartment House: Every person in the business of  
9 conducting an apartment house shall obtain a semi-annual  
10 license therefor, per the following schedule; provided,  
11 however, that in cases where the same person owns a  
12 group of apartment houses which are contiguous to each  
13 other, such contiguous group shall be treated as one  
14 apartment house for the purposes of this subsection:

26 [(G)] (H) Architect: \$50.00 semi-annually for all architects  
27 registered and certified by the Nevada State Board of  
28 Architecture and conducting a private practice, whether  
29 as a sole practitioner or as a partner or associate in  
30 a firm, and whether the practice is full time or  
31 supplementary to employment with a Federal, State or  
32 local government agency..

1 [(H)] (I) Armored Cars: See LVC Title V, Chapter 48 for fees  
2 and regulations.

3 [(I)] (J) Assayer: \$50.00 semi-annually.

4 [(J)] (K) Astrologer: See LVC Title V, Chapter 10, Section 2  
5 for fees and regulations.

6 [(K)] (L) Attorney: \$50.00 semi-annually for each attorney  
7 admitted to the Nevada State Bar and conducting a  
8 private practice, whether as a sole practitioner or  
9 as a partner or associate in a firm, and whether the  
10 practice is full-time or supplementary to employment  
11 with a Federal, State, or local government agency.

12 [(L)] (M) Auctioneer: See LVC Title V, Chapter 6 for fees and  
13 regulations.

14 [(M)] (N) Automobile Leasing: \$50.00 semi-annually for each  
15 business leasing automobiles or any other kind of  
16 motor vehicle.

17 [(N)] (O) Automobile Rental Agency: See LVC Title V, Chapter 7  
18 for fees and regulations.

19 [(O)] (P) Automobile Towing Service: \$50.00 semi-annually for  
20 each automobile towing service. This subsection shall  
21 not apply to service stations and garages which, as an  
22 incident to providing repairs, tow automobiles to their  
23 place of business to make such repairs.

24 SECTION 2: Title V, Chapter 1(A), Section 5 of the  
25 Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is  
26 hereby amended to read as follows:

27 5-1(A)-5:

28 (A) Certified Shorthand Reporter: \$50.00 semi-annually for  
29 each shorthand reporter or court reporter holding a  
30 certificate of registration under NRS 656.

31 (B) Chiropractor: \$50.00 semi-annually for every chiro-  
32 practor holding a valid State license under NRS 634 and

- 1 conducting a private practice, whether as a sole  
2 practitioner or as a partner or associate in a firm,  
3 and whether the practice is full-time or supplementary  
4 to employment with a Federal, State, or local government  
5 agency.
- 6 (C) Coin-Operated Amusement Machines: See LVC 5-7-1 for  
7 fees and regulations.
- 8 (D) Collection Agency: \$50.00 semi-annually for each  
9 collection agency holding a State license under  
10 NRS 649.
- 11 (E) Commodity Brokerage Firm: \$250.00 semi-annually for  
12 each establishment engaged in the business of effecting  
13 transactions in commodity options as defined by  
14 NRS 90.042, whether as broker-dealers, agents, or  
15 issuers as such terms are defined in NRS 90.
- 16 (F) Contractors: \$100.00 semi-annually for each person  
17 required by NRS 624 to have a State contractor's  
18 license. A City of Las Vegas contractor's license  
19 shall not be issued or renewed until and unless such  
20 person has in effect a valid State contractor's license.
- 21 (G) Cosmetological Establishment: For each cosmetological  
22 establishment issued a State license under NRS 644, the  
23 fee is \$25.00 semi-annually for the first person  
24 practicing cosmetology as defined by NRS 644.020(3)  
25 (which includes hairdressers, manicurists and electro-  
26 logists), and \$10.00 for each additional person  
27 practicing cosmetology therein.
- 28 (H) Credit Bureau: \$50.00 semi-annually for each credit  
29 bureau and branch office thereof.
- 30 [(H)] (I) Credit Union: \$50.00 semi-annually for each credit  
31 union and branch office thereof.
- 32 [(I)] (J) Contract Labor Service: \$50.00 semi-annually for

1 each person who by contract supplies his own employees  
2 to perform only temporary labor services for another  
3 under circumstances in which the individuals performing  
4 the labor do not become employees of the recipient of  
5 the services.

6 [(J)] (K) Coupon Book Sales: See LVC Title V, Chapter 20 for  
7 fees and regulations.

8 SECTION 3: Title V, Chapter 1(A), Section 17 of the  
9 Municipal Code of the City of Las Vegas, Nevada, 1960 Edition,  
10 is hereby amended to read as follows:

11 5-1(A)-17:

12 (A) Real Estate Appraiser: \$50.00 semi-annually for each  
13 real estate appraiser whether working alone or as a  
14 member or employee of a firm.

15 [(A)] (B) Real Estate Developer: See LVC 5-7-2 for fees and  
16 regulations.

17 [(B)] (C) Real Estate Broker: \$50.00 semi-annually. Where  
18 there shall be two (2) or more persons, members of  
19 a real estate firm or partnership, or officers of a  
20 corporation engaged in the real estate brokerage  
21 business, the annual license fee for each such member  
22 shall be fifty dollars (\$50.00), payable in semi-annual  
23 installments on billing dates. The semi-annual license  
24 fee for each branch thereof shall be one dollar (\$1.00).

25 [(C)] (D) Real Estate Salesman; Real Estate Broker - Salesman:  
26 \$10.00 semi-annually, after a State license has been  
27 issued under NRS 645, whether working as an employee  
28 or an independent contractor and whether associated  
29 with a licensed real estate broker or an owner-developer.

30 [(D)] (E) Rental Referral Service: \$50.00 semi-annually for  
31 each person providing a listing of rental properties  
32 available to the public on behalf of the owners of

1           such properties, but not acting as an agent for  
2           the collection of rental fees.

3 [(E)] (F) Repossessor: See Title V, Chapter 3 for fees and  
4           regulations.

5 [(F)] (G) Retail Demonstration Merchandise Sales: See LVC  
6           Title V, Chapter 36 for fees and regulations.

7 [(G)] (H) Retail Tobacco Dealers: \$10.00 semi-annually.

8 [(H)] (I) Riding Horses, Renting: \$50.00 semi-annually for  
9           each person providing riding horses for rent.

10           SECTION 4: Title V, Chapter 1(A), Section 18 of the  
11 Municipal Code of the City of Las Vegas, Nevada, 1960 Edition,  
12 is hereby amended to read as follows:

13 5-1(A)-18:

14 (A)           Savings and Loan Associations: \$250.00 semi-annually  
15           for each savings and loan association or branch thereof,  
16           incorporated and licensed under NRS 673.

17 (B)           Schools: \$50.00 semi-annually for each private school,  
18           college or trade school. An applicant for a license  
19           to conduct a school must have a State license therefor  
20           or present proof that a State license is not required.

21 (C)           School Nurseries and Child Care: See LVC Title II,  
22           Chapter 5 for fees and regulations.

23 (D)           Secondhand Dealers: See LVC Title V, Chapter 8 for fees  
24           and regulations.

25 (E)           Services-Technical and Miscellaneous: \$50.00 semi-  
26 annually for each person providing technical or  
27 miscellaneous services not otherwise specified in  
28 this chapter.

29 [(E)] (F) Sightseeing Buses and Limousines: \$25.00 semi-annually  
30           for each bus used by a bus company in the business of  
31           carrying passengers for hire and not operated over  
32           fixed routes or between definite points. See LVC

1 Title X, Chapter 2 for additional licensing require-  
2 ments. Applicant must furnish certificates of public  
3 convenience and necessity from the Public Service  
4 Commission in accordance with NRS 625.

5 [(F)] (G) Sign Painting Establishment: \$50.00 semi-annually for  
6 each sign painting establishment not required to have  
7 a State contractor's license.

8 [(G)] (H) Skating Rink: \$50.00 semi-annually.

9 [(H)] (I) Solicitors: See LVC Title V, Chapter 11 for fees and  
10 regulations.

11 [(I)] (J) Sound Amplification Devices: See LVC Title V,  
12 Chapter 39 for fees and regulations.

13 [(J)] (K) Stenographer, Public: \$50.00 semi-annually for every  
14 person other than a certified shorthand reporter who  
15 makes a business of typing for the general public or  
16 for persons other than himself or his immediate  
17 employer.

18 [(K)] (L) Stock Brokerage Firm: \$250.00 semi-annually for each  
19 establishment engaged in the business of effecting  
20 transactions in securities as defined by NRS 90.090.

21 [(L)] (M) Surveyors: \$50.00 semi-annually for each person  
22 conducting the business of surveying land as defined  
23 by NRS 625.040 and who has a State license therefor  
24 under NRS 625.

25 SECTION 5: If any section, subsection, subdivision,  
26 paragraph, sentence, clause or phrase in this Chapter or any  
27 part thereof, is for any reason held to be unconstitutional, or  
28 invalid or ineffective by any court of competent jurisdiction,  
29 such decision shall not affect the validity or effectiveness of  
30 the remaining portions of this Chapter or any part thereof. The  
31 Board of Commissioners of the City of Las Vegas hereby declares  
32 that it would have passed each section, subsection, subdivision,

1 paragraph, sentence, clause or phrase thereof irrespective of  
2 the fact that any one or more sections, subsections, subdivisions,  
3 paragraphs, sentences, clauses or phrases be declared unconstitu-  
4 tional, invalid or ineffective.

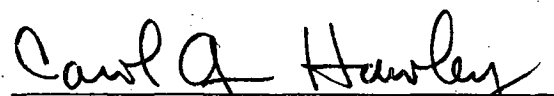
5 SECTION 6: All ordinances or parts of ordinances,
