ORDINANCE No. 3011

AN ORDINANCE TO AMEND TITLE X, CHAPTER 8, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, 1960 EDITION, BY PROVIDING A NEW SECTION 11 RELATING TO TOUR BUS LOADING ZONES, AND BY PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

Summary: Provides for tour bus loading zones.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title X, Chapter 8 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended by adding a new Section 11 to read as follows:

10-8-11: Upon those streets or highways or parts of streets or highways described in Schedule 18-VI a copy of which is to be maintained for public inspection in the office of the City Clerk and the office of the City Traffic Engineer, which may be amended from time to time by resolution of the Board of Commissioners, it shall be unlawful to stop, stand or park a vehicle for any purpose or length of time other than for the expeditious loading and unloading of passengers from a licensed tour bus in any place marked as a Tour Bus Loading Zone during hours where the provisions applicable to such zones are in effect. In no case shall the stop for unloading and loading of passengers exceed thirty (30) minutes.

SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this Chapter or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this Chapter or any part thereof. The Board of Commissioners of the City of Las Vegas, Nevada, hereby declares that it would have passed each section, subsection, sub-

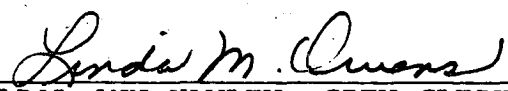
1 division, paragraph, sentence, clause or phrase thereof irrespec-
2 tive of the fact that any one or more sections, subsections,
3 subdivisions, paragraphs, sentences, clauses or phrases be
4 declared unconstitutional, invalid or ineffective.

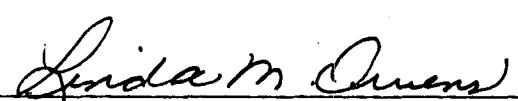

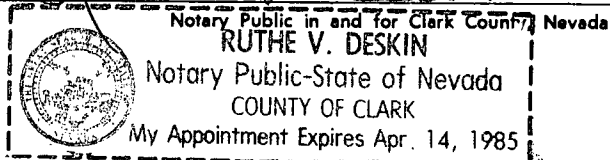
