AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 6, SUBSECTION H, PARAGRAPH 1, SUBPARAGRAPH b, SUB-SUBPARAGRAPH 12 TO PROVIDE FOR A NEW METHOD OF DETERMINING THE NUMBER OF PARKING SPACES REQUIRED FOR AN OFFICE BUILDING; AND TO PROVIDE OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title XI, Chapter 1, Section 6, Subsection H, Paragraph 1, Subparagraph b, Sub-subparagraph 12 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

11-1-6(H)1(b)12: Office Building: One space for each [five hundred (500)] four hundred (400) square feet of gross floor area [, or one and one half (1½) spaces per office employee, whichever is greater.] except that buildings which contain more than twenty thousand square feet of gross floor area shall provide one space per four hundred (400) square feet of gross floor area, or one and one half (1½) parking spaces per employee, whichever is greater unless it is determined by the Planning Commission that all of the additional parking spaces based on the number of employees are not necessary. Further, regardless of the building size or number of employees, no office development shall have less than [four (4)] six (6) spaces; provided, however, that the Planning Commission may permit less than six (6) spaces upon a showing by the applicant that the size and use of both the building and the lot would necessitate a lesser number of spaces.

SECTION 2: If any section, subsection, subdivision,

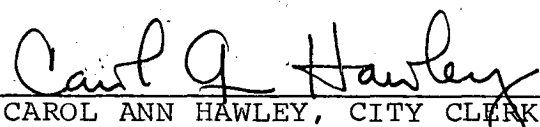
1 paragraph, sentence, clause or phrase in this Chapter or any part
2 thereof, is for any reason held to be unconstitutional or invalid
3 or ineffective by any court of competent jurisdiction, such deci-
4 sion shall not affect the validity or effectiveness of the
5 remaining portions of this Chapter or any part thereof. The
6 Board of Commissioners of the City of Las Vegas, Nevada, hereby
7 declares that it would have passed each section, subsection, sub-
8 division, paragraph, sentence, clause or phrase thereof irrespec-
9 tive of the fact that any one or more sections, subsections,
10 subdivisions, paragraphs, sentences, clauses or phrases be
11 declared unconstitutional, invalid or ineffective.

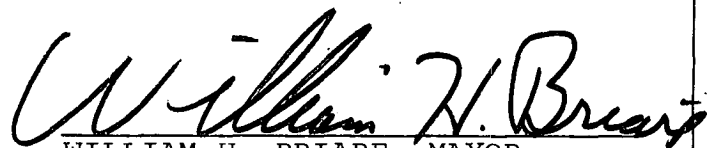

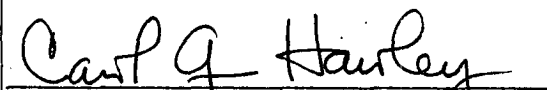

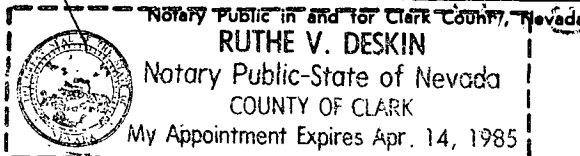
