18 THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS,
19 NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

20 SECTION 1: Title XII of the Municipal Code of the City
21 of Las Vegas, Nevada, 1960 Edition, is hereby amended by adding
22 thereto a new chapter, to be designated as Chapter 2, reading as
23 follows:

24 CHAPTER 2

25 TELEPHONIC COMMUNICATION FRANCHISE

26 12-2-1: GRANT OF FRANCHISE: The City of Las Vegas, Nevada
27 hereby grants to Central Telephone Company the non-
28 exclusive right, privilege, authority and permission
29 to install, use and maintain telephonic communications
30 equipment in, upon, along, across, above, over and
31 under the public roads within the incorporated
32 boundaries of the City of Las Vegas, subject to and in
accordance with the terms and conditions of that certain
document entitled Franchise Agreement, dated the 17th day

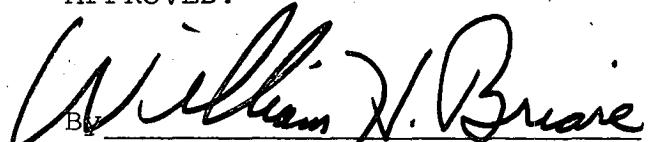
1 of November, 1982, by and between the City of Las Vegas
2 and Central Telephone Company, a copy of which said
3 Agreement is on file with the Clerk of the City of Las
4 Vegas and by this reference incorporated herein as a
5 part of this Chapter.

6 SECTION 2: If any section, subsection, subdivision,
7 paragraph, sentence, clause or phrase in this Chapter or any
8 part thereof, is for any reason held to be unconstitutional, or
9 invalid or ineffective by any court of competent jurisdiction,
10 such decision shall not affect the validity or effectiveness of
11 the remaining portions of this Chapter or any part thereof. The
12 Board of Commissioners of the City of Las Vegas hereby declares
13 that it would have passed each section, subsection, subdivision,
14 paragraph, sentence, clause or phrase thereof irrespective of
15 the fact that any one or more sections, subsections, subdivisions,
16 paragraphs, sentences, clauses or phrases be declared unconstitu-
17 tional, invalid or ineffective.

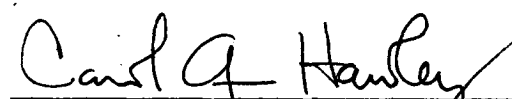
18 SECTION 3: All ordinances or parts of ordinances,

21 1960 Edition, in conflict herewith are hereby repealed.

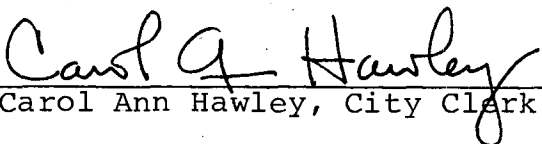
