AN ORDINANCE AMENDING TITLE IV OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY REPEALING CHAPTER 4 THERE- OF AND ADDING THERETO A NEW CHAPTER 4 AND AMENDING TITLE 16, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY REPEALING CHAPTER 24 THEREOF AND ADDING THERETO A NEW CHAPTER 24, ADOPTING BY REFERENCE THE UNIFORM MECHANICAL CODE, 1982 EDITION, AS PART 1 THEREOF AND ADOPTING A SUPPLEMENTAL DOCUMENT PROVIDING AMENDMENTS, CHANGES AND DELETIONS TO THE UNIFORM MECHANICAL CODE, 1982 EDITION, AS PART 2 THEREOF, PROVIDING REGULATIONS FOR THE INSTALLATION, REPAIR, SERVICING, MAINTENANCE AND IMPROVEMENT OF HEATING AND AIR CONDITIONING EQUIPMENT AND DUCTWORK; PROVIDING FOR THE INSPECTION THEREOF; PROVIDING FOR THE LICENSING OF PERSONS, FIRMS OR CORPORATIONS ENGAGED IN THE BUSINESS OF INSTALLING, REPAIRING, SERVICING, MAINTAINING AND IMPROVING HEATING AND AIR CONDITIONING EQUIPMENT AND DUCTWORK; PROVIDING FOR ISSUANCE OF PERMITS IN CONNECTION WITH SUCH WORK; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Adopts the Uniform Mechanical Code, 1982 Edition, provides regulations for the installation, repair, service, maintenance, and improvement of heating and air conditioning equipment and ductwork and the inspection thereof and provides for the licensing of persons doing air conditioning work.

THE BOARD OF CITY COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title IV, Chapter 4, of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, and Title 16, Chapter 24 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, are hereby repealed.

SECTION 2: Title IV, of the Municipal Code of the City of Las Vegas, Nevada 1960 Edition, and Title 16, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, are hereby amended by adding thereto a new Chapter, to be designated Chapter 4, and Chapter 24, respectively, reading as

1 follows:

2 4-4-1: Those certain documents, three (3) copies of
3 (16.24.010) each being on file in the office of the City Clerk,
4 Las Vegas, Nevada, and designated as follows, are
5 hereby adopted by reference and made a part of this
6 Code, to the same effect as if set out herein in
7 full:

8 (A) Uniform Mechanical Code, 1982 Edition, and
9 hereby designated as Part 1 of this Chapter;
10 and

11 (B) A supplemental document amending, deleting and
12 adding to the Uniform Mechanical Code, 1982
13 Edition, and hereby designated as Part 2 of
14 this Chapter.

15 SECTION 3: The Board of Commissioners hereby
16 declares that it would have adopted each separate provision of
17 this Chapter, regardless of the adoption of any other provision,
18 and if any section, paragraph, sentence, phrase, term, word or
19 connotation of this ordinance, or portion thereof, is for any
20 reason held invalid, inapplicable or unconstitutional by any
21 court of competent jurisdiction, such holding shall not invali-
22 date the remaining portions of this ordinance.

23 SECTION 4: Any person, firm or corporation violating
24 any of the provisions of this ordinance shall, upon conviction
25 thereof, be punished by a fine of not more than \$1,000.00 and/or
26 imprisonment in the City Jail for not more than six (6) months,
27 or any combination of such fine and imprisonment. Every day of
28 such violation shall constitute a separate offense.

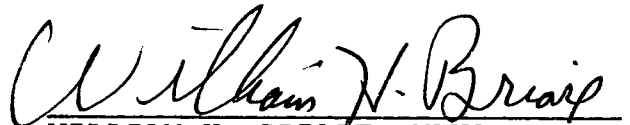

1 A SUPPLEMENTAL DOCUMENT, ADOPTED BY REFERENCE, COMPLETING THE UNIFORM
2 MECHANICAL CODE OF THE CITY OF LAS VEGAS, NEVADA, AND HEREBY DESIGNATED
3 PART 2 OF TITLE IV, CHAPTER 4, SECTIONS 1 THROUGH 8 AND ALSO DESIGNATED
4 AS ORDINANCE NO. 3025.

5 SECTION 1: AMENDMENTS: Certain Sections or Chapters of the Uniform
6 Mechanical Code, as proposed in Section 1, Subsection A of Title IV,
7 Chapter 4, the 1982 Edition Uniform Mechanical Code, shall be deleted,
8 modified, added and amended as hereinafter provided.

9 SECTION 2: LICENSING: Any person, firm or corporation engaged in
10 the business of installing, repairing, servicing, maintaining or improving
11 heating and air conditioning equipment or ductwork in the City of Las Vegas,
12 County of Clark, State of Nevada, shall first secure a State of Nevada
13 Contractor's License and a business license from the Director of the
14 Department of Business Activity for which a semi-annual license fee shall
15 be charged. Said license must be kept valid as long as the applicant is
16 engaged in the installation, repairing, servicing, maintaining or
17 improving heating and air conditioning equipment or ductwork.

18 SECTION 3: ADVERTISING:

19 (a) Except as provided in Subsection (b) of this Section, it
20 shall be unlawful for any person, firm or corporation not the holder of a
21 valid license issued hereunder to engage in, carry on, or represent himself,
22 itself or themselves as engaging in or carrying on heating, air conditioning
23 or ductwork installation, repairing, servicing, maintenance or improvement
24 or to use the words "heating" or "air conditioning" either alone or in
25 combination with other words in any advertising or display or cause to be
26 displayed or to use or cause to be used on any sign or in any media of
27 advertising, words communicating the same or similar import for the purpose
28 of implying the advertiser or the person, firm or corporation being advertised
29 to be engaged in any aspect of the business regulated by this Code.

30 (b) Nothing in this Section shall be construed to restrict or
31 prevent the right of any bona fide manufacturer or seller of heating and
32 air conditioning equipment, not involved with the installation, repair,
service or maintenance thereof, to advertise its products or equipment in

1 any lawful manner it may choose, provided, however, that any such
2 manufacturer or seller shall not advertise in conjunction or cooperation
3 with any unlicensed person, firm or corporation who engages or seeks to
4 engage in any aspect of business regulated by this Code.

5 SECTION 4: QUALIFIED PERSON:

6 (a) It is unlawful for any person who is not qualified to
7 install, alter, reconstruct, repair or maintain any heating, ventilating,
8 air conditioning or refrigeration equipment or evaporative cooler or
9 cooling towers as described in this Code unless such person is a qualified
10 person or a regular salaried employee of a qualified person, in which
11 latter case, the qualified person shall be responsible for all work done
12 by such employee.

13 (b) The term "qualified person" shall be deemed to mean a
14 person, firm or corporation holding both a valid contractor's license
15 issued by the State of Nevada and a valid City license issued by the
16 Department of Business Activity of the City or one who is a homeowner as
17 defined in subparagraph (c):

18 (c) Any permit required by this Code may be issued to any
19 person doing any construction or work regulated by this Code in a single
20 family dwelling used exclusively for living purposes, including usual
21 accessory buildings and quarters in connection with such single family
22 dwelling, provided:

23 1. That such person is a bona fide owner of such dwelling,
24 accessory building and quarters; and

25 2. That the same are occupied by or intended to be occupied
26 by such owner; and

27 3. That for the installation of any equipment such owner
28 shall be required to apply for and obtain a permit for such construction
29 or work; provided, however, that no permit will be required for the repair,
30 service or maintenance of existing equipment.

31 SECTION 5: STOP ORDERS

32 (d) Section 201 (d) of the Mechanical Code is hereby amended

as follows:

Whenever any work is being done contrary to the provisions of this Code, or contrary to a permit issued, the Building Official may order work stopped by notice in writing served on any person engaged in the doing or causing such work to be done, and any such person shall forthwith stop such work until authorized by the Building Official, to proceed with the work. Whenever any work has been stopped for reason above, a fee of \$20.00 shall be paid to the City before any work pertaining to the stop order can again commence. Any person who shall knowingly proceed to do building work in violation of any stop order shall be guilty of a misdemeanor.
