AN ORDINANCE TO AMEND TITLE VIII, CHAPTER 3, SECTION 15, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, AND ALSO TITLE 9, CHAPTER 8, SECTIONS 140, 150, 160 AND 170, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983, EDITION, TO ESTABLISH A REVISED SCHEDULE OF CHARGES FOR COLLECTING, HAULING AND DISPOSING OF GARBAGE IN THE CITY OF LAS VEGAS EITHER BY SAID CITY OR BY ITS AUTHORIZED CONTRACTOR; TO PROVIDE OTHER MATTERS PROPERLY RELATING THERETO; AND TO REPEAL ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title VIII, Chapter 3, Section 15 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

8-3-15: (A) Single-family residence. The charge for collecting, hauling and disposing of garbage, rubbish, dirt and dead animals from single-family residence on a twice-a-week basis, shall be as follows:

[~~\$13.84~~] \$18.00 per quarter, payable in advance, each and every three (3) month period.

(B) Apartments and Multiple Units. The charge for collecting, hauling and disposing of garbage, rubbish, dirt and dead animals from apartments and multiple units on a twice-a-week basis shall be a flat rate to be computed as follows:

[~~\$10.33~~] \$13.43 for the first unit on one stop and [~~\$7.23~~] \$9.40 for each additional unit on one stop, irrespective of occupancy or vacancy

1 of any such additional unit or units, payable
2 each and every three (3) month period.

3 Should six (6) day service be requested by
4 any apartments or multiple units, the rate
5 for service shall be two and one-half (2-1/2)
6 times that for service for a twice-a-week
7 basis.

8 (C) Auto Courts and Mobile Home Parks. The charge
9 for collecting and hauling garbage, rubbish, dirt
10 and dead animals from auto courts and mobile home
11 parks on a twice-a-week basis, shall be as follows:

12 Offices - [\$10.33] \$13.43 per quarter;
13 Sleeping rooms and mobile homes without
14 cooking facilities - [\$4.70] \$6.11 per
15 quarter; Rooms where cooking facilities
16 are furnished or mobile homes with cook-
17 ing facilities - [\$6.21] \$8.07 per quar-
18 ter; Mobile homes where individual collec-
19 tions are required - [\$10.33] \$13.43 per
20 quarter; payable each and every three (3)
21 months, payable in advance, commencing on
22 and continuing on the first day of each
23 and every three (3) months period there-
24 after. Should six (6) day service be re-
25 quested by any Auto Courts and Mobile Home
26 Parks, the rate for service shall be two
27 and one-half (2-1/2) times that for service
28 for a twice-a-week basis.

29 (D) Hotels, Places of Business and Public Buildings.
30 The quarterly charge for collecting, hauling and
31 disposing of garbage, rubbish, dirt and dead
32 animals from hotels, places of business and public

buildings shall be determined by the number and type of receptacles required by each such hotel, place of business or public building and by the number of daily collections from each per week in accordance with the following table:

22 hereby amended to read as follows:

23 9-08-140: The charge for collecting, hauling and disposing of
24 garbage, rubbish, dirt and dead animals from single-
25 family residences on a twice-a-week basis shall be as
26 follows: [thirteen dollars and eighty-four cents]
27 eighteen dollars per quarter, payable in advance, each
28 and every three-month period.

29 SECTION 3: Title 9, Chapter 8, Section 150, of the
30 Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is
31 hereby amended to read as follows:

1 9.08.150: The charge for collecting hauling and disposing of
2 garbage, rubbish, dirt and dead animals from apartments
3 and multiple units on a twice-a-week basis shall be a
4 flat rate to be computed as follows: [ten dollars and
5 thirty-three] thirteen dollars and forty-three cents for
6 the first unit on one stop and [seven dollars and
7 twenty-three] nine dollars and forty cents for each
8 additional unit on one stop, irrespective of occupancy
9 or vacancy of any such additional unit or units, pay-
10 able each and every three-month period. Should six-day
11 service be requested by any apartments or multiple
12 units, the rate for service shall be two and one-half
13 times that for service for a twice-a-week basis.

16 hereby amended to read as follows:

6 posing of garbage, rubbish, dirt, and dead animals from
7 hotels, places of business and public buildings shall
8 be determined by the number and type of receptacles re-
9 quired by each such hotel, place of business or public
10 building and by the number of daily collections from
11 each per week in accordance with the following table:

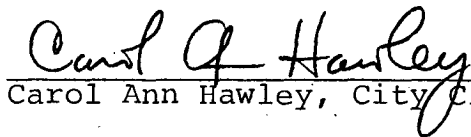

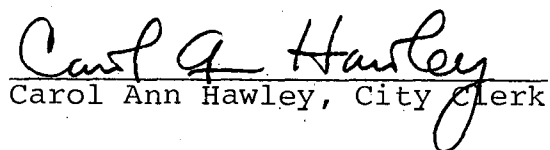

[\$10.33] \$13.43 for the first unit on one stop and [\$7.23] \$9.40 for each additional unit on one stop, irrespective of occupancy or vacancy of any such additional unit or units, payable
