

ORDINANCE NO. 934-19

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3, MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING CLASSIFICATION OF CERTAIN AREAS OF THE SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DO ORDAIN AS FOLLOWS:

SECTION 1. The Land Use Map adopted by Title XI, Chapter 1, Section 3, Municipal Code of the City of Las Vegas, Nevada, 1960, is hereby amended to read as follows:

From R-E to R-3 (Z-54-62)

Lot 7, Block 7, Artesian Acres, Shown in Book 1 of Plats, Page 38, in the Office of the County Recorder of Clark County, Nevada.

From R-E to R-1 (Z-62-62)

The Northwest Quarter (NW1/4) of the Northwest Quarter (NW1/4) of Section 25, Township 20 South, Range 60 East, M.D.B. & M.

From R-4 to C-1 (Z-63-62)

Lots 3, 4 and 5, Block 1, Subdivision of Block 1, Park Place Addition to the City of Las Vegas, Nevada.

From R-E to R-1 (Z-64-62)

The East one-half (E1/2) of the Northwest Quarter (NW1/4) of Section 25, Township 20 South, Range 61 East, except the North forty (40) feet for street and road purposes.


From R-1 to R-4 (Z-65-62)

Lots 358 and 359, Block 17, Hyde Park Subdivision No. Three.

SECTION 2. All ordinances, parts of ordinances, chapters, sections, subsections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960, in conflict herewith are hereby repealed.

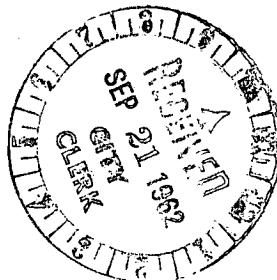

From R-1 to R-4 (Z-65-62)
