

ORDINANCE NO. 934-15

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3, MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING CLASSIFICATION OF CERTAIN AREAS OF THE SAID MAP.

The Board of Commissioners of the City of Las Vegas do ordain as follows:

SECTION 1. The Land Use Map adopted by Title XI, Chapter 1, Section 3, Municipal Code of the City of Las Vegas, Nevada, 1960, is hereby amended to read as follows:

From R-E to C-1 (Z-6-61-Revised)

That property bounded on the south by the north right of way line of Charleston Boulevard, on the northeasterly side by the southwesterly right of way line of Rancho Road, and on the west by the east right of way line of the proposed Rancho Road realignment as shown on Engineering Department Map titled Rancho Road-Charleston Boulevard crossing, right of way acquisition Drawing No. 115-70 dated 1/15/62, save and except that portion now zoned C-1.

SECTION 2. All ordinances, parts of ordinances, chapters, sections, sub-sections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960, in conflict herewith are hereby repealed.

Road realignment as shown on Engi-
neering Department Map titled
Rancho Road-Charleston Boulevard
crossing, right of way acquisition
Drawing No. 115-70, dated 1/15/62,
save and except that portion now
zoned C-1.

sections, paragraphs, sentences, clauses
or phrases contained in the Muni-
cipal Code of the City of Las Vegas,
Nevada, 1960, in conflict herewith are
hereby repealed.

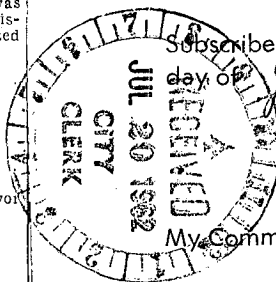
