

ORDINANCE NO. 934-1

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3, MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF CERTAIN AREAS OF THE SAID MAP.

The Board of Commissioners of the City of Las Vegas do ordain as follows:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3, Municipal Code of the City of Las Vegas, Nevada, 1960, is hereby amended to read as follows:

From R-E to R-1: (Z-39-61)

The Southwest Quarter (SW $\frac{1}{4}$) of Section 6, Township 21 South, Range 61 East, MDB&M.

(Z-40-61)

The Southeast Quarter (SE $\frac{1}{4}$) of the Northeast Quarter (NE $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section 30, Township 20 South, Range 61 East, MDB&M

(Z-43-61)

The South one-half (S $\frac{1}{2}$) of the North one-half (N $\frac{1}{2}$) of the Southeast Quarter (SE $\frac{1}{4}$) of the Northwest Quarter (NW $\frac{1}{4}$); the north one-half (N $\frac{1}{2}$) of the South one-half (S $\frac{1}{2}$) of the Southeast Quarter (SE $\frac{1}{4}$) of the Northwest Quarter (NW $\frac{1}{4}$) and the north one-half (N $\frac{1}{2}$) of the North one-half (N $\frac{1}{2}$) of the North one-half (N $\frac{1}{2}$) of the South one-half (S $\frac{1}{2}$) of the South one-half (S $\frac{1}{2}$) of the Southeast Quarter (SE $\frac{1}{4}$); Northwest Quarter (NW $\frac{1}{4}$) of Section 6, Township 21 South, Range 61 East, MDB&M.

From R-E to C-1: (Z-38-61)

The south 50 feet of the north 250 feet of the west 330 feet of the Northwest Quarter (NW $\frac{1}{4}$) of Section 25, Township 20 South, Range 61 East, MDB&M.

(Z-48-61)

That portion of Government Lot IV, Section 6, Range 61 East, Township 21 South, located east of Decatur Boulevard as shown on the Major Street Plan of the City of Las Vegas.

From R-4 to C-1: (Z-44-61)

Lots one and two of Subdivision of Block "I" Park Place Addition.

(Z-45-61)

Lots 25, 26, 27 and 28, Block 3, Pioneer Heights plus the adjoining portion of Lot 6, Block 21, Bucks Subdivision.

From R-3 and R-4 to R-3-T: (Z-49-61)

The Southeast Quarter (SE $\frac{1}{4}$) of the Southeast Quarter (SE $\frac{1}{4}$) of Section 21, Township 20 South, Range 61 East; save and except the north 175 feet, the west 400 feet, the south 480 feet, and the east 200 feet of the south 555 feet of the north 730 feet.

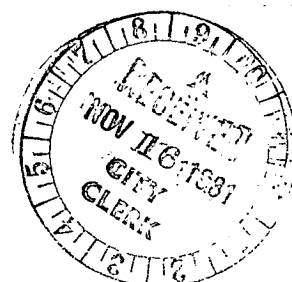
