

ORDINANCE NO. 934-90

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1; Section 3 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

FROM R-1 and R-3 to C-1 (Z-4-66)

The South 445.0 feet of the West 1545.0 feet of the Southeast Quarter (SE 1/4) of Section 31, Township 20 South, Range 61 East, M.D.B.&M.

The East 335.0 feet of the North 265.0 feet of the Northwest Quarter (NW 1/4) of the Southeast Quarter (SE 1/4) and the North 275.0 feet of the West 225.0 feet of the Northeast Quarter (NE 1/4) of the Southeast Quarter (SE 1/4) of Section 31, Township 20 South, Range 61 East, M.D.B.&M.

The South 265.0 feet of the East 335.0 feet of the Southwest Quarter (SE 1/4) of the Northeast Quarter (NE 1/4) of Section 31, Township 20 South, Range 61 East, M.D.B.&M.

FROM R-3 to C-1 (Z-71-64)

Lots 13 and 14 and the West 43.00 feet of Lot 12, Block 1, Las Verdes Heights Addition No. 6, Unit No. 5.

SECTION 2. All ordinances, parts of ordinances, chapters, sections, subsections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.
