

ORDINANCE NO. 934-80

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF CERTAIN AREAS OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3, of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

FROM R-4 TO C-1 (Z-20-63)

Lot 1, Lawrence Love Tract.

FROM R-1 TO C-1 (Z-64-63)

The East 100.00 feet of the West 202.00 feet of the South 200.00 feet of Government Lot 62, Section 36, Township 20 South, Range 60 East, M.D.B.&M.

FROM R-1 TO C-1 (Z-29-64)

The East 100.00 feet of the West 202.00 feet of the North 130.00 feet of Government Lot #62, Section 36, Township 20 South, Range 60 East, M.D.B.&M.

FROM R-3 TO C-1 (Z-95-64)

The East 15 feet of Lot 1, Lots 2 through 6, inclusive, the West 50.00 feet of Lot 9 and the East 90.00 feet of Lot 48, all in Block 6, Las Vegas Square.

SECTION 2. All ordinances, parts of ordinances, chapters, sections, subsections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

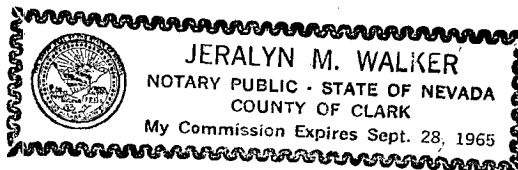
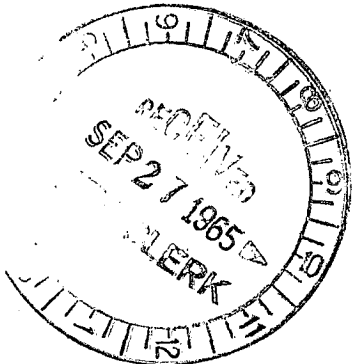
