

ORDINANCE NO. 934-79

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF CERTAIN AREAS OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3, of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

FROM R-2 to P-R (Z-43-65)

Lot 46 and the East 12.5 feet of Lot 47, Block 1, Paradise Village Tract #1.

FROM R-3 to P-R (Z-160-63)

Lots 13 through 16 (inclusive), Block 1, Paradise Village Tract # 1.

FROM R-1 to C-1 (Z-42-65)

Lot 1 and the South 31.43 feet of Lot 2, Block 1, Golf Ridge Terrace # 1.

SECTION 2. All ordinances, parts of ordinances, chapters, sections, sub-sections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

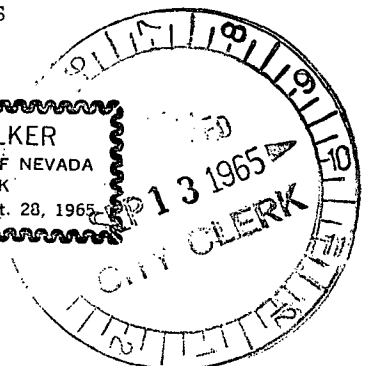
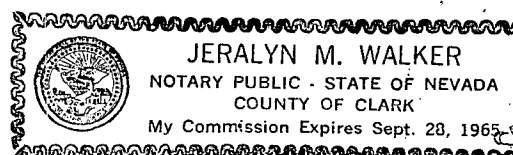
