AN ORDINANCE TO EXTEND THE BOUNDARIES OF THE CITY OF LAS VEGAS WHICH PARTICULARLY DESCRIBES THE LAND TO BE ANNEXED, MAKES ITS INHABITANTS SUBJECT TO THE LAWS AND OBLIGATIONS OF THE CITY AND PROVIDES FOR OTHER MATTERS RELEVANT TO THE ANNEXATION. (A-46-99(A))

Summary: Annexes property described generally as located on the northeast corner of Buckskin Avenue and Puli Drive.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
AS FOLLOWS:

SECTION 1: The corporate limits of the City of Las Vegas, Nevada, are hereby extended to include, annex to, and make a part of the City of Las Vegas, Nevada, the following described real property, to-wit:

The West Half (W ½) of the Southwest Quarter (SW ¼) of the Northwest Quarter (NW ¼) of the Southwest Quarter (SW ¼) of Section 12, Township 20 South, Range 59 East, M.D.M., in the County of Clark, State of Nevada.

SECTION 2: That said City Council has determined and does hereby determine, that said described territory meets the requirements provided by law for annexation to the City of Las Vegas for the following reasons:

- A. The area to be annexed was contiguous to the City's boundaries at the time the annexation proceedings were instituted;
- B. More than one-eighth (1/8) of the aggregate external boundaries of the area are contiguous to the City of Las Vegas;
- C. The territory proposed to be annexed is not included within the boundaries of another incorporated city or within the boundaries of any unincorporated town as those boundaries existed as of July 1, 1983;
- D. The City of Las Vegas is eligible to annex the area described in this report since the landowners have signed a petition constituting one hundred percent (100%) of the owners of record of individual lots or parcels of land within the

1 annexation area.

2 SECTION 3: The City of Las Vegas will provide police protection through the Las
3 Vegas Metropolitan Police Department, fire protection, street maintenance, and library services
4 immediately upon annexation. Garbage collection by the company franchised by the City will also
5 be provided immediately. The City sanitary sewer system will serve the proposed annexation area.
6 Any connection to or extension of this sewer line to serve the annexation area shall be at the expense
7 of the landowners. Other services, such as participation in the City's recreational programs, special
8 education classes and programs, public works planning, building inspections, and other City services
9 will also be available immediately. Utilities such as gas, electricity, telephone, and water are provided
10 by private utility companies and other services to the area will not be affected by annexation. Street
11 paving, curbs and gutters, sidewalks and street lights which are not in place at the time of annexation
12 will be installed in the presently developed areas upon the request of the property owners and at their
13 expense by means of special assessment districts. Such improvements will be extended into the
14 undeveloped areas as development takes place and the need therefor arises, and will be located
15 according to the needs of the area at that time. Such installations will also be made at the expense of
16 the property owners, either by means of special assessment districts or as prerequisites to the approval
17 of subdivision plats, building permits or other land use or development applications.

18 SECTION 4: The annexation of said described territory shall become effective on the
19 25th day of February, 2000, and on such date the City of Las Vegas will have the funds appropriated
20 in sufficient amount to finance the extension into said described territory of police protection, fire
21 protection, street maintenance, street sweeping, and street lighting maintenance.

22 SECTION 5: Said described territory, together with the inhabitants and property
23 thereof, shall, from and after the 25th day of February, 2000, be subject to all debts, laws, ordinances
24 and regulations in force in the City of Las Vegas and shall be entitled to the same privileges and
25 benefits as other parts of said City, and shall be subject to municipal taxes levied by the City of Las
26 Vegas, Nevada.

27 SECTION 6: The City Engineer of the City of Las Vegas, Nevada, is hereby instructed
28 to cause to be prepared an accurate map or plat of said described territory and to record the same,

1 together with a certified copy of this ordinance in the office of the County Recorder of Clark County,
2 Nevada, which said recording shall be done prior to the 25th day of February, 2000.

3 SECTION 7: The said described territory, which heretofore has been zoned R-U
4 (County of Clark classification), is hereby classified as U (PCD) (City of Las Vegas classification),
5 which is deemed to be the City equivalent of said County classification.

6 SECTION 8: If any section, subsection, subdivision, paragraph, sentence, clause or
7 phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid
8 or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
9 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
10 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
11 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
12 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
13 invalid or ineffective.

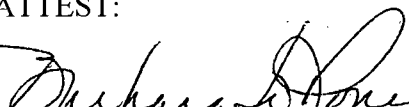
14 SECTION 9: All ordinances or parts of ordinances, sections, subsections, phrases,

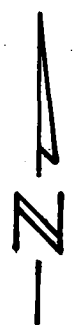
