AN ORDINANCE RELATING TO GAMING CONTROL; AMENDING TITLE 6, CHAPTER 40, SECTION 165, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, TO EXTEND, UNDER CERTAIN CIRCUMSTANCES, THE PERIOD DURING WHICH GAMING OPERATIONS MAY BE DISCONTINUED AT A LOCATION AT WHICH RESTRICTED OR NONRESTRICTED GAMING IS CONDUCTED BY VIRTUE OF SUCH LOCATION'S HAVING BEEN LICENSED FOR SUCH GAMING ON NOVEMBER 1, 1988, OR APRIL 1, 1989, AS THE CASE MAY BE, OR BEING SITUATE IN ONE OF THE SO-CALLED "RED-LINED" DISTRICTS THAT PREVIOUSLY EXISTED WITHOUT SUCH LOCATION'S FORFEITING ITS RIGHT TO HAVE SUCH GAMING CONDUCTED THEREAT; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Extends, under certain circumstances, the "grandfather" rights to licensing of certain locations at which gaming operations have been discontinued for 24 consecutive months.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 6, Chapter 40, Section 165, of the Municipal Code of the City of Las Vegas, Nevada 1983 Edition, is hereby amended to read as follows:

6.40.165: [If] (A) Except as is otherwise provided in subsection (B), if gaming operations at any location at which restricted gaming may be conducted by virtue of LVMC 6.40.140(A) or at any location at which nonrestricted gaming may be conducted by virtue of LVMC 6.40.150(A)(1), 6.40.150(A)(2), 6.40.150(B)(1) or 6.40.150(B)(2) are discontinued for twenty-four consecutive months, the right to conduct gaming at such [establishment] location by virtue of LVMC 6.40.150(A)(1), 6.40.150(A)(2), 6.40.150(B)(1) or 6.40.150(B)(2), as the case may be, shall, upon the expiration of such twenty-four-month period, automatically terminate, and no gaming may be conducted at such location unless or until such location is licensed for restricted gaming pursuant to

some other provision of LVMC 6.40.140 or for nonrestricted gaming pursuant to some other provision of LVMC 6.40.150.

(B) If the discontinuance of the gaming operations at such location is in connection with the proposed demolition of the gaming facility that is situate thereon and the construction of a new facility, the right to conduct gaming at such location shall not terminate if a building permit for the construction of the new facility is issued, and, with respect to a location which is licensed for nonrestricted gaming and at which the nonrestricted gaming is to be continued, an application for nonrestricted gaming is filed with the State, within such twenty-four month period and the restricted or nonrestricted, as the case may be, gaming operations at such location are resumed within forty-eight months after the gaming operations were discontinued.

SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. Said City Council hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases may be declared unconstitutional, invalid or ineffective.
