ORDINANCE NO. 3117

AN ORDINANCE RELATING TO MEETINGS OF THE CITY COUNCIL; AMENDING TITLE 2, CHAPTER 2, SECTION 60, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, TO PROVIDE THAT WHEN THE DATE FOR A REGULAR MEETING OF THE CITY COUNCIL FALLS ON A LEGAL HOLIDAY, THE NEXT SUCCESSIVE BUSINESS DAY SHALL BE THE DATE FOR THAT MEETING UNLESS THE CITY COUNCIL DETERMINES THAT SUCH MEETING SHALL BE HELD ON A DIFFERENT DATE AND FOR RECESSING A MEETING OF THE CITY COUNCIL IF A QUORUM IS NOT PRESENT; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Establishes method of determining dates of regular meetings of City Council when official dates therefor fall on legal holidays and provides for recessing a meeting if a quorum is not present.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS, NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 2, Chapter 2, Section 60, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

- 2.02.060: (A) A regular meeting of the [Board] City Council shall be cancelled if [such meeting] it falls on a Wednesday which is designated as a holiday in Chapter 3.16[.] and shall be held on the first successive day which is not a holiday; provided, however, that the City Council may, at any regular meeting thereof which is held prior to the meeting which is cancelled by virtue of this Subsection (A), establishes a different date for such meeting.
- (B) A regular meeting of the [Board] City Council may be cancelled in advance thereof by the Mayor or by any two members of the [Board] City Council if it appears that a quorum of the [Board] City Council will not be present at such meeting[.

1 (C) In the event that a regular meeting of the Board is
2 cancelled under either Subsection (A) or (B) of this
3 Section,], and all matters which were scheduled for
4 [public hearing] consideration at that meeting shall
5 automatically be placed on the agenda for the next
6 regular meeting of the [Board,] City Council, and
7 the City Clerk shall give notice of such cancella-
8 tion and rescheduling by any means reasonably
9 calculated to give notice thereof to all interested
10 parties.

11 (C) If a majority of the members of the City Council
12 fails to appear at any regular or special meeting
13 thereof, the member or members in attendance may
14 recess such meeting to a time certain or cancel
15 the same pursuant to Subsection (B) of this Section.
16 If the meeting is recessed to a time certain, no
17 notice of the new date and time need be given.

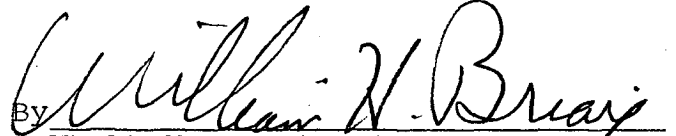
18 SECTION 2: If any section, subsection, subdivision,
19 paragraph, sentence, clause or phrase in this Chapter or any part
20 thereof, is for any reason held to be unconstitutional or invalid
21 or ineffective by any court of competent jurisdiction, such decision
22 shall not affect the validity or effectiveness of the remaining
23 portions of this Chapter or any part thereof. The City Council
24 of the City of Las Vegas, Nevada, hereby declares that it would
25 have passed each section, subsection, subdivision, paragraph,
26 sentence, clause or phrase thereof, irrespective of the fact that
27 any one or more sections, subsections, subdivisions, paragraphs,
28 sentences, clauses or phrases be declared unconstitutional, invalid
29 or ineffective.

30 SECTION 3: All ordinances or parts of ordinances,

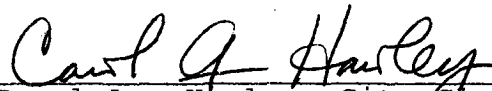
