AN ORDINANCE RELATING TO BUSINESS LICENSING LAWS; AMENDING TITLE 6, CHAPTER 28, SECTION 10 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, TO ADD DEFINITIONS OF "CONVENTION" AND "TRADE SHOW;" PROVIDING FOR OTHER MATTERS RELATING THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Adds definitions of "convention" and "trade show" to chapter on convention and trade show business licenses.

THE CITY COUNCIL OF LAS VEGAS, NEVADA, DOES HEREBY
ORDAIN AS FOLLOWS:

SECTION 1: Title 6, Chapter 28, Section 10 of the
Municipal Code of the City of Las Vegas, 1983 Edition, is hereby
amended to read as follows:

6.28.010: The following definitions apply to this Chapter:

(A) "Convention" means a meeting with an established
agenda consisting of speakers or other programs that
address matters of concern to those attending the
meeting. The meeting may also include times and places
at which convention exhibitors demonstrate, display,
sell or offer for sale goods or services that reasonably
relate to the primary interests of the convention.

[(A)] (B) "Convention exhibitor" means any person who sells,
offers for sale or solicits orders for the sale of
goods or services on a temporary basis at a bona fide
international, national, state or local convention.

[(B)] (C) "Convention operator" means any person who
sponsors or organizes a convention wherein space is
provided for convention exhibitors.

(D) "Trade show" means a show featuring lines of
reasonably related goods or services which exhibitors
demonstrate, display, sell or offer for sale. Gather-

1 ings of sellers of unrelated merchandise are deemed
2 not to be trade shows as defined by this subsection.
3 [(C)] (E) "Trade show exhibitor" means any person who sells,
4 offers for sale or solicits orders for the sale of
5 goods or services on a temporary basis at a bona fide
6 international, national, state or local trade show or
7 fair.
8 [(D)] (F) "Trade show operator" means any person who sponsors
9 or organizes a trade show wherein space is provided
10 for a trade show exhibitor.
11 SECTION 2: If any section, subsection, subdivision,
12 paragraph, sentence, clause or phrase in this ordinance or any
13 part thereof, is for any reason held to be unconstitutional or
14 invalid or ineffective by any court of competent jurisdiction,
15 such decision shall not affect the validity or effectiveness of
16 the remaining portions of this ordinance or any part thereof.
17 The City Council of the City of Las Vegas, Nevada, hereby declares
18 that it would have passed each section, subsection, subdivision,
19 paragraph, sentence, clause or phrase thereof irrespective of
20 the fact that any one or more sections, subsections, subdivisions,
21 paragraphs, sentences, clauses or phrases be declared unconstitu-
22 tional, invalid or ineffective.
