AN ORDINANCE TO AMEND THE MASTER PLAN OF STREETS AND HIGHWAYS PROVIDED FOR IN TITLE 13, CHAPTER 12, SECTION 30 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY REDUCING THE RIGHT-OF-WAY WIDTH OF THE WEST HALF OF DECATUR BOULEVARD BETWEEN CHEYENNE AVENUE AND MOCCASIN ROAD FROM SIXTY FEET (60') TO FIFTY FEET (50'); TO PROVIDE FOR OTHER MATTERS PROPERLY RELATING THERETO; AND TO REPEAL ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS, NEVADA DOES
HEREBY ORDAIN AS FOLLOWS:

SECTION 1: The Master Plan of Streets and Highways provided for in Title 13, Chapter 12, Section 30 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended as follows:

The right-of-way width of the west half of Decatur Boulevard between Cheyenne Avenue and Moccasin Road is reduced from sixty feet (60') to fifty feet (50').

SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this Chapter or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this Chapter or any part thereof. The Board of Commissioners of the City of Las Vegas, Nevada, hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

1 SECTION 3: All ordinances or parts of ordinances,
2 sections, subsections, phrases, sentences, clauses or paragraphs
3 contained in the Municipal Code of the City of Las Vegas, Nevada,
4 1983 Edition, in conflict herewith are hereby repealed.
