ORDINANCE No. 3098

AN ORDINANCE TO AMEND TITLE 13 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY ADDING THERETO A NEW CHAPTER, DESIGNATED AS CHAPTER 58, TO PROHIBIT THE LAUNCHING OR LANDING OF AIRCRAFT IN PUBLIC STREETS AND RIGHTS-OF-WAY AND PARKING LOTS PROVIDED FOR THE USE OF THE PUBLIC, EXCEPT IN SPECIFIED CIRCUMSTANCES; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Councilman Robert Nolen	Prohibits the launching or landing of aircraft in public streets, highways, rights-of-way and parking lots provided for the use of the public, except in specified circumstances.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS, NEVADA DOES
HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 13 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto a new chapter, designated as Chapter 58 and consisting of Sections 13.58.010 to 13.58.030, inclusive, reading as follows:

13.58.010: For purposes of this Chapter, "aircraft" means any vehicle used for navigation through the air.

13.58.020: Except as otherwise provided in Section 13.58.030, it is unlawful for any person to cause or permit any aircraft to be launched from or land upon the following areas within the City:

A) Any public street, highway or other public right-of-way.

B) Any parking lot which is provided for the use of the public.

13.58.030: Section 13.58.020 shall not apply to the launching or landing of any aircraft:

A) Which is being operated by or at the direction of any governmental entity;

B) Pursuant to prior authorization by the City Council; or

1 C) Where an emergency launching or landing is necessary in
2 order to protect life or property.

3 SECTION 2: If any section, subsection, subdivision,
4 paragraph, sentence, clause or phrase in this Chapter or any part
5 thereof, is for any reason held to be unconstitutional or invalid
6 or ineffective by any court of competent jurisdiction, such deci-
7 sion shall not affect the validity or effectiveness of the
8 remaining portions of this Chapter or any part thereof. The
9 City Council of the City of Las Vegas, Nevada, hereby declares
10 that it would have passed each section, subsection, subdivision,
11 paragraph, sentence, clause or phrase thereof irrespective of the
12 fact that any one or more sections, subsections, subdivisions,
13 paragraphs, sentences, clauses or phrases be declared unconstitu-
14 tional, invalid or ineffective.

15 SECTION 3: Whenever in this ordinance any act is
16 prohibited or is made or declared to be unlawful or an offense or
17 a misdemeanor, or whenever in this ordinance the doing of any act
18 is required or the failure to do any act is made or declared to
19 be unlawful or an offense or a misdemeanor, the doing of any such
20 prohibited act or the failure to do any such required act shall
21 constitute a misdemeanor and upon conviction thereof, shall be
22 punished by a fine of not more than \$1,000.00 or by imprisonment
23 for a term of not more than six (6) months, or by any combination
24 of such fine and imprisonment. Any day of any violation of this
25 ordinance shall constitute a separate offense.
